SRI JAYAWARDANAPURA KOTTE MUNICIPAL COUNCIL

A Draft Copy for levying tax subject to the undeveloped lands for the year 2016

TO levy taxes in subject to the lands undeveloped for the year 2016 by the Sri Jayawardanapura Kotte Municipal Council under Section 247(d) of the Municipal Council Ordinance (Chapter 252) in the Penal Code of Sri Lanka.

Where any land situated within the jurisdiction of Sri Jayawardanapura Kotte Municipal Council, which is suitable to construct a building or cultivate daily or permanent, it can be developed for any purpose on a reasonable expense according to the opinion of this Council,

- (a) When no constructed building in that land ; or
- (b) If the relevant ratio enforced by the Council by an accepted resolution and when it is less than, the ratio between the amount of real submerged land and the whole amount of land ; or
- (c) Unless that land used for a permanent otherwise daily cultivation,

The following tax has imposed from the capital value of the lands of such lands :

- 1. When houses can construct up to 2,000 sq. ft. in the lands below 06 perches otherwise from the capital value of the land 0.5%
- 2. When houses can construct up to 3,000 sq. ft. in the lands below 06 to 10 perches otherwise from the capital value of the land 1%.
- 3. When houses can construct above 10 perches otherwise from the cpaitla value of the land 1.5%.

In any case it is not covered by the above 1, 2, 3 then 2% tax will be charged from the owner of that land from the capital value.

It is hereby notified to the public that the Sri Jayawardanapura Kotte Municipal Council has been enforced tax subject to the undeveloped lands as mentioned above under the order of Council Decision No. 06:01 (with amendments) of the Municipal Council for the year 2016 and to the relevant amendments done herein after, held on 28th August 2015, 17th December 2015.
