THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, John Anthony Emmanuel Amarathunga, Minister of Lands, hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, that the lands described below are needed for a public purpose and will be acquired under the provisions of that Act.

The allotments of below name lands in total extent of about 0.0589 Hectare, depicted in Advance Tracing No. Ka/DDN/15/593 and dated 23/12/2015, prepared by the Surveyor General, situated in the Village of Kethhena in Divisional Secretary's Division of Dodangoda in the Kaluthara District in Western Province and bounded as follows:

01. Lot 'A' – Paramulle Owita – Extent: 0.0130 Hectare

North: Paramulle Owita claimed by Don Chandrani; East: Paramulle owita claimed by Road(R. D. A.); South: Paramulle Owita claimed by Road(R. D. A.) and Lot B; West: Lot B, Paramulle Owita claimed by Paramullage Don Pemawathi, Paramullage Don Sriyani and Paramullage Don Chandrani Malkanthi.

03. Lot 'C' – Iriyangalladeniya – Extent: 0.0147 Hectare

North: Klaidewatta, Iriyangalladeniya claimed by Superintendent and Iriyangalla Canal; East: Iriyangalladeniya claimed by Road (R. D. A.); South: Iriyangalladeniya claimed by Road (R. D. A.); West: Klaidewatta, Iriyangalladeniya claimed by Superintendent.
