LAND SALES IN THE SOUTHERN PROVINCE.

THE Government Agent, Southern Province, Galle, is prepared to receive on or before January 31, 1919, at the Galle Kachcheri, written applications for the lease in perpetuity from April 6, 1919, of the under-mentioned portions of Crown land to be planted with coconuts, rubber, tea, or other produce. No such applications will be entertained unless the applicant gives his full name and address, and until he makes with the Government Agent a deposit of survey fees as noted against each lot. Such deposit will not be returned until the lease of the land has been decided by the Government Agent that it will not be sold.

Conditions of Lease.

The lease of the lot shall be granted in perpetuity at the upset price of Rs. 20 as premium, subject to a rental of Re. 1 per acre or fraction thereof per annum.

The annual rent for the first six years shall be at the rate of one-third of the full amount.

No building shall be erected without the permission of the Government Agent.

Any building or buildings erected without the permission of the Government Agent or contrary to the conditions shall be the property of the Crown.

Permission shall only be granted for the erection of such buildings which are necessary for the cultivation of native products. The lot shall be used for the cultivation of native products only.

The lessee shall be bound to plant the land to the extent of one-tenth in each of the first five years of the lease and a further fourth within the next five years. For non-compliance of this condition the whole area of the lease, except the portion actually cultivated, shall become liable to the payment of double rent.

The rent shall be subject to revision at intervals of thirty years.

The rent shall not be increased by more than 50 per cent. of the rent for the previous 30-year period.

The lessee shall not assign the lease or transfer any right or interest, or subject the whole or any portion of the land leased, without the previous consent of the lessor.
