NOTIFICATION MADE UNDER STATE LAND REGULATION No. 21 (2)

IT is hereby notified that for the purpose of Commercial, Peacock Park Beach Resort Private Limited has requested on lease a State land containing in extent about 03 Acres out of extent marked of Lot No. A as depicted in the Tracing No. PLC/EP/28/SUR/01/2011/031 situated in the Village of Kumpurupiddi which belongs to the Grama Niladhari Division of Kumpurupiddy coming within the area of authority of Kuchchaweli Divisional Secretariat in the District of Trincomalee.

02. Given below are the boundaries of the land requested :

On the North by: Road and Reservation along the sea;

On the East by : Low Jungle State Land ;

On the South by: Low Jungle State land and Land Occupied by Vythiyalingam ;

On the West by : Road and Land Occupied by Vythiyalingam .

The land requested can be given on lease for the necessary purpose. Therefore, the Government has intended to lease out the land subject to other Government approved conditions:-

(a) *Terms of the Lease.*- Thirty (30) Years , (from 27.10.2015);

The Annual Rent of the Lease.-4% of the commercial value of the land as per valuation of the Chief Valuer for the Year 2015. This amount of the lease must be quinquennially revised in such a manner that the amount as a result of the revision will be not less than 50% of the amount that just preceded.

Premium .- Treble 4% of the developed value of the land ;

- (b) The lessee must, within one year of the commencement of the lease, develop the said land, in such a manner as to captivate the mind of the Divisional Secretary ;
- (c) The lessee must not use this land for any purposes other than for the Commercial Activities ;
- (d) This lease must also be subject to the other special conditions stipulated and imposed by the Divisional Secretary/Scoping Committee/ Board of Investment of Sri Lanka and by other institutions;
- (e) The buildings constructed must be maintained in a proper state of repair.
- (f) Once the land is given on lease and in the event of failure on the part of the lessees to substantiate within the specified time frame the purpose for which the land was obtained, action will be taken to terminate the lease ;
- (g) No sub - leasing can be done until the expiry of a minimum period of 05 years ;
- (h) Payment of the lease must be regularly made and if defaulted in payment, the agreement will *ipso facto* lapse.

If acceptable reasons are not submitted to me in writing within six weeks of the date herein below to the effect that this land must not be given on lease, the land will be leased out as requested.
