IT is hereby notified that for the purpose of Commercial, Peacock Park Beach Resort Private Limited has requested on lease a State land containing in extent about 03 Acres out of extent marked of Lot No. A as depicted in the Tracing No. PLC/EP/28/SUR/01/2011/031 situated in the Village of Kumpurupiddi which belongs to the Grama Niladhari Division of Kumpurupiddy coming within the area of authority of Kuchchaweli Divisional Secretariat in the District of Trincomalee.

- (*b*) The lessee must, within one year of the commencement of the lease, develop the said land, in such a manner as to captivate the mind of the Divisional Secretary;
- (c) The lessee must not use this land for any purposes other than for the Commercial Activities;
- (d) This lease must also be subject to the other special conditions stipulated and imposed by the Divisional Secretary/Scoping Committee/ Board of Investment of Sri Lanka and by other institutions;
- *(e)* The buildings constructed must be maintained in a proper state of repair.
- (f) Once the land is given on lease and in the event of failure on the part of the lessees to substantiate within the specified time frame the purpose for which the land was obtained, action will be taken to terminate the lease ;
- g) No sub leasing can be done until the expiry of a minimum period of 05 years;
- (*h*) Payment of the lease must be regularly made and if defaulted in payment, the agreement will *ipso facto* lapse.

If acceptable reasons are not submitted to me in writing within six weeks of the date herein below to the effect that this land must not be given on lease, the land will be leased out as requested.
