**Order under Section 3**

**South :**

From the last mentioned point a line drawn West, South, West, South, West, South-west, South, West, North-west, South-west, West, North and North-west wards along the northern boundary of the Hanwella divisional secretariat division until it meets the intersecting point of the northern and eastern boundaries of the Homagama divisional secretariat division ; thence, a line drawn West, North and North-west wards along the northern boundary of the Homagama divisional secretariat division until it meets the northern and western boundaries of the Kaduwela divisional secretariat division ; thence, a line drawn South-west, West,
