**Appropriation Statute**

**2016**

For the year 2016

**A Statute to amend the Appropriation Statute No. 04 of the 2015, of the Sabaragamuwa Provincial Council of the Democratic Socialist Republic of Sri Lanka**

1. This Statute may be cited as the Sabaragamuwa Provincial Council Appropriation (Amendment) Statute No. 02 of the 2016, and shall come into operation of the date of receiving the assent of the Governor of the Sabaragamuwa Province.
2. The expenditure of the Sabaragamuwa Provincial Council which is estimated Rupees Twenty Six Thousand and Fourteen Million and Four Hundred and Ninety Eight Thousand Only (Rs. 26,014,498,000.00) for the service of the period beginning on 1st of January, 2016 and ending 31st of December, 2016 in this Statute referred to as the "Financial Year 2016", the first Schedule is hereby amended as the expenditure of the Sabaragamuwa Provincial Council which is estimated Rupees Twenty Nine Thousand Six Hundred and Fifty Million and Two Hundred and Nineteen Thousand Five Hundred and Seventy One and Cents Thirty only (Rs. 29,650,219,571.30) for the service of the period beginning on 01st January 2016 and ending 31st of December 2016 in this statute referred to as the "Financial Year 2016" as the First Schedule hereof.
3. The limits mentioned in the Second Schedule of the Appropriation Statute No. 04 of 2015 relevant to the limits of the Advanced Accounts in hereby amended as per the second schedule hereof.
