A Statute to amend the appropriation Statute No. 10 of 2014 as amended by Appropriation (Amended) Statute No. 03 of 2015.

01. This Statute may be cited as the Sabaragamuwa Provincial Council Appropriation Statute No. 03 of 2016, and shall come into operation of the date of receiving the assent of the Governor of the Sabaragamuwa Province.
