THE LAND ACQUISITION ACT (CHAPTER 460)

Notice under Section 7

My Reference No.: MCUDP/LA/MUT (W-14)/14/02/A.

I, hereby give notice, under Sub-section (1) of Section 7 of the Land Acquisition Act, as amended by the Land Acquisition (Amendment) Act, No. 28 of 1964, that the Government intends to acquire the lands for the construction of a tunnel to create a drainage way from the main canal in Aluth Mawatha area up to the sea, under the Metro Colombo Urban Development Project.

Description of the land to be acquired:

Four (04) allotments of lands described in following names and extents and total extent of 0.1746 hectare, depicted as lot No. 31, 32, 34 and 35 in the Preliminary Plan No. Co. 9653 dated 18.08.2016 prepared by the Surveyor General situated in the village called Muthuwal in the Grama Niladhari Division of Lunu Pokuna, Aluth Mawatha in the Divisional Secretary's Division of Colombo in Colombo District of the Western province and more fully described as follows.
