### DRAFT ORDINANCES.

#### MINUTE.

The following Draft of a proposed Ordinance is published for general information :—

#### An Ordinance further to amend "The Land Acquisition Ordinance, 1876."

Preamble.

WHEREAS it is expedient further to amend "The Land Acquisition Ordinance, 1876": Be it therefore enacted by the Governor of Ceylon, by and with the advice and consent of the Legislative Council thereof, as follows :

Short title.

1 This Ordinance may be cited as "The Land Acquisition (Amendment) Ordinance, No. of 1921."

Amendment of section 28 of the principal Ordinance.

2 Section 28 of the principal Ordinance is amended by striking out the words "Provided that such fee shall not exceed two hundred rupees" in line 3 thereof.

#### *Statement of Objects and Reasons.*

COMPENSATION cases may, and often do, involve large values, and take a long time to investigate; and strong representations have been made to the effect that the limitation of the fee allowed to assessors to two hundred rupees, irrespective of the importance, complexity, or length of the case, is not advisable. By this amendment it is proposed that the amount of the fee payable to an assessor should be left to the discretion of the judge who presides at the hearing.

## MINUTE.

The following Draft of a proposed Ordinance is published for general information :—

An Ordinance further to amend "The Criminal Procedure Code, 1898."

Preamble.

WHEREAS it is expedient further to amend "The Criminal Procedure Code, 1898": Be it therefore enacted by the Governor of Ceylon, by and with the advice and consent of the Legislative Council thereof, as follows :

Short title.

1 This Ordinance may be cited as "The Criminal Procedure Code (Amendment) Ordinance, No. of 1921."

Insertion of new chapter in principal Ordinance.

2 The following provisions shall be inserted as Chapter XX. A of the principal Ordinance :—

CHAPTER XX. A.

*Of Expenses of Witnesses, &c., Costs, and Compensation.*

Power of Governor in Executive Council to make regulations.

253 A. (1) The Governor in Executive Council may make regulations providing—

- (a) For the payment out of the public revenue of the expenses of persons attending to give evidence for the prosecution or defence or called to give evidence at the instance of the court for the expense, trouble, or loss of time properly incurred in, or incidental to, the attendance and giving of evidence in any trial before the Supreme Court or a District Court, or on the inquiry preliminary to any such trial, and the conditions on which such payments may be allowed;
- (b) For the payment out of the public revenue of the expenses of persons summoned to serve as jurors or assessors in any trial before the Supreme Court or a District Court, respectively;
- (c) For the persons by whom, and the manner in which, the amounts of such expenses shall be ascertained and payments made.

(2) Such regulations shall be laid as soon as conveniently may be before the Legislative Council, and may at any time within forty days after the date of their being so laid before the Council, or at any of the three meetings of the Council next succeeding such date, by resolution of the Council, be disallowed, amended, or otherwise dealt with as may be directed by the said Council, but without prejudice to anything that may have been done thereunder.

Power of Supreme Court or District Court to order payment of costs of prosecution by defendant.

253 B. (1) The Supreme Court or any District Court by or before which any person is convicted of an indictable offence may, if it thinks fit, in addition to any other lawful punishment, order the person convicted to pay the whole or any part of the costs incurred in or about the prosecution and conviction, including any proceedings in the preliminary inquiry before a Magistrate, as taxed by the Registrar or Secretary of the court.

(2) Any sum awarded under this section shall be recoverable as if it were a fine; and also, if the court so direct, out of any money taken on his apprehension from the person convicted.

(3) Any amount so recovered shall be paid into the public Treasury.

Frivolous or vexatious complaints.

253 C. (1) If in any case instituted on complaint under section 148 (1) (a) which a Police Court has power to try, a Magistrate acquits or discharges the accused and declares that the complaint was frivolous or vexatious, it shall be lawful for such Magistrate to order the complainant to pay by way of Crown costs a sum not exceeding five rupees, and he may, in addition, at the same time, order the complainant to pay to the accused, or to each of the accused when there are more than one, such compensation not exceeding ten rupees to each person as the Magistrate shall think fit, which sum if paid or recovered shall be taken into account in any subsequent civil suit relating to the same matter.

(2) Any sum awarded under this section shall be recoverable as if it were a fine, and if it cannot be recovered, the imprisonment to be awarded shall be simple and for such term, not exceeding in the case of a sum awarded by way of compensation thirty days, and in the case of a sum awarded by way of Crown costs fourteen days, as the Magistrate directs at the time of awarding such sum.

(3) Before making any such order the Magistrate shall record and consider any objection which the complainant may urge against the making of the order, and if he makes such order, he shall record his reasons for making the same.

(4) No appeal shall lie against any order for payment of Crown costs.

Compensation for groundlessly giving in charge.

253 D. (1) Whenever any person causes a peace officer to arrest another person, if it appears to the Magistrate who takes cognizance of the case that there was no sufficient ground for causing such arrest, he may award such compensation not exceeding twenty-five rupees to be paid by the person so causing the arrest to the person so arrested for his loss of time and expenses in the matter as the Magistrate thinks fit.

(2) In such cases, if more persons than one are arrested, the Magistrate may in like manner award to each of them such compensation not exceeding twenty-five rupees as such Magistrate thinks fit.

(3) All compensation awarded under this section may be recovered as if it were a fine, and if it cannot be so recovered, the person by whom it is payable shall be sentenced to simple imprisonment for such term not exceeding thirty days as the Magistrate directs, unless such sum be sooner paid.

(4) Such compensation shall be no bar to an action for false imprisonment.

Power of court to pay expenses or compensation out of fine.

253 E. (1) Whenever a criminal court imposes a fine or passes a sentence of which fine forms a part, or the Supreme Court confirms in appeal, revision, or otherwise a sentence of a fine or sentence of which fine forms a part, such court may order the whole or any part of the fine recovered to be applied—

(a) In defraying the expenses properly incurred in the prosecution; or

(b) In compensation for the injury caused by the offence committed where substantial compensation is, in the opinion of the court, recoverable by civil suit.

(2) If the fine is imposed in a case which is subject to appeal, no such payment shall be made before the period allowed for presenting the appeal has elapsed, or, if an appeal be presented, before the decision of the appeal.

(3) At the time of awarding compensation in any subsequent civil suit relating to the same matter, the court shall take into account any sum paid or recovered as compensation under this section.

Power of court to order payment of compensation to aggrieved party.

253 F. (1) Whenever any person (hereafter referred to as the convict) is convicted by or before a criminal court, or the Supreme Court confirms in appeal, revision, or otherwise a sentence, such court may order the convict to pay such sum by way of compensation to any person affected by the offence (hereafter referred to as the aggrieved party) as to the court shall seem fit. Provided that in the case of a person convicted before a Magistrate the amount awarded by him shall not exceed fifty rupees to each aggrieved party.

(2) Any sum awarded under this section shall be recovered as if it were a fine, and if and when recovered shall be paid over to the aggrieved party.

Proviso.

Repeal.

3 Sections 197, 198, 277, 431, 432, and 437 of the principal Ordinance and section 54 of "The Police Ordinance, 1865," are hereby repealed.

*Statement of Objects and Reasons.*

THIS Bill gives effect to certain recommendations made by a Committee appointed by His Excellency the Governor to consider amongst other things the subject of costs, expenses of witnesses, and compensation in criminal cases.

The provisions dealing with these subjects in the Criminal Procedure Code are not grouped, but in the Bill these provisions are proposed to be included in a single chapter of the Code.

Payments to jurors and assessors are provided for by regulations under section 277 of the Code and for witnesses under section 431; but the Committee called attention not only to the inadequacy of the rates of payment which were laid down in 1883, but also to such distance limits as are specified in section 277.

Section 253 A (set out in section 2 of the Bill) is intended to give wide powers of making regulations for payment of the expenses of witnesses, jurors, and assessors, and is substituted for sections 277 and 431 of the Code. These regulations may be amended or disallowed by the Legislative Council.

Section 253 B (set out in section 2 of the Bill) is new, and is intended to give the Supreme and the District Courts power to order a convicted person to pay the costs of his trial in accordance with the provisions of the English law.

Section 253 C, 253 D, and 253 E (set out in section 2 of the Bill) merely re-enact the provisions of sections 197 and 198, 437, and 431, respectively, of the Code.

Section 253 F (set out in section 2 of the Bill) is new, and gives all criminal courts power to order an offender to make compensation to the aggrieved party.

## MINUTE.

The following Draft of a proposed Ordinance is published for general information :—

**An Ordinance further to amend "The Civil Procedure Code, 1889."**

Preamble.

WHEREAS it is expedient further to amend "The Civil Procedure Code, 1889": Be it therefore enacted by the Governor of Ceylon, by and with the advice and consent of the Legislative Council thereof, as follows :

Short title.

1 This Ordinance may be cited as "The Civil Procedure Code (Amendment) Ordinance, No. of 1921."

Substitution of new section for section 122 of the principal Ordinance.

2 Section 122 of the principal Ordinance is hereby repealed, and the following shall be inserted in lieu thereof :—

Payment of witness' costs.

122 (1) The party applying for a summons shall, before the summons is granted, and within a period to be fixed by the court, pay into court, or give security for payment of, such a sum of money as appears to the court to be sufficient to defray the travelling and other expenses of the person summoned in passing to and from the court in which he is required to attend, and for one day's attendance. Provided that the making of any such payment and the giving of any such security shall in no case be a condition precedent to the issue of a summons, but in every case where summons issues without such payment having been made or security given, the witness shall be informed on the face of the summons that such is the case, and that it is not obligatory on him to attend.

(2 a) Notwithstanding anything in this section contained, any person who has been summoned by a court to give evidence or to produce a document, and who resides more than ten miles away from such court, may, by registered letter addressed to the Judge of such court or by personal application, object to the issue of such summons, on the ground that he can give no material evidence with respect to the matters in dispute in the particular suit or matter.

(2 b) The Judge shall thereupon call upon the party at whose instance the summons was issued to prove by affidavit, to the satisfaction of the Judge; that there are reasonable grounds for believing that the evidence of the person summoned is material, and if the Judge is not so satisfied, he shall direct that the issue of the summons be set aside and that no further proceedings be taken thereon.

Amendment of section 208 of the principal Ordinance.

3 Section 208 of the principal Ordinance is amended by striking out the words "charges of witnesses" in line 7 thereof and substituting therefor the words "such just and reasonable charges as appear to have been properly incurred in procuring evidence and the attendance of witnesses."

*Statement of Objects and Reasons.*

A COMMITTEE appointed by His Excellency the Governor to report, amongst other matters, on the proper method of compensating witnesses in civil cases for attendance at court have recommended that the present scale of compensation be increased.

Sections 122 and 124 of the Civil Procedure Code merely require the travelling expenses and expenses of attendance of a witness to be paid, and there is no compensation provided for his loss of time. Similarly, no provision exists for the remuneration of expert witnesses who have to fit themselves to give evidence in a case. The Committee recommended that the English method of remunerating witnesses be adopted, and effect has been given to this recommendation by section 3 of the Bill.

Section 122 of the Civil Procedure Code does not allow of expenses being paid to a witness who lives within four miles of the court, but this limitation has been left out, as the distance makes little difference; it is the taking up of the time of the witness that is material.

Another point raised has been the abuse that sometimes occurs of summoning a person as a witness who has no material evidence to give. It is obvious that no undue difficulties should be put in the way of a person presenting his case; it is equally desirable to give protection against the abuse of the process of the court. In section 122 (2) of the Civil Procedure Code, which is set forth in section 2 of the Bill, an attempt has been made to find a reasonable way of effecting these two, partly contradictory, objects.

The following Draft of a proposed Ordinance is published for general information:—

**An Ordinance to declare the terms and conditions applicable to Loans authorized to be raised by the Government of Ceylon and to provide for the creation of Ceylon Inscribed Stock.**

Preamble.

WHEREAS it is expedient to define in one Ordinance the terms and conditions applicable to loans hereafter authorized to be raised by the Legislature of the Colony of Ceylon:

And whereas it is expedient to provide for the creation of inscribed stock, and to enable the Colony to take advantage of the provisions of an Act of the Imperial Parliament entitled "The Colonial Stock Act, 1877," and the subsequent Acts on the same subject:

Enacting clause.	Be it therefore enacted by the Governor of Ceylon, by and with the advice and consent of the Legislative Council thereof, as follows :
Interpretation.	<p>1 In this Ordinance, unless the context otherwise requires—</p> <p>The expression " Governor " means the person for the time being administering the Government of Ceylon ;</p> <p>The expression " Crown Agents " means the person or persons for the time being acting as Crown Agents for the Colonies in England.</p>
Loans to be raised by debentures or inscribed stock.	<p>2 Whenever by any Ordinance authority shall have been given, or shall hereafter be given, to raise any sum of money for the purposes mentioned in such Ordinance, the Governor, or the Crown Agents acting on his behalf, may from time to time, as he or they may deem expedient, raise such sum either by debentures or by Ceylon inscribed stock, or partly by debentures and partly by inscribed stock.</p>
Loans to be a charge upon general revenue.	<p>3 The principal moneys and interest represented by the debentures or inscribed stock issued under the provisions of this Ordinance are hereby charged upon and shall be payable out of the general revenues and assets of the Colony of Ceylon.</p>
Borrowing upon debentures.	<p>4 When the Governor, or the Crown Agents acting on his behalf, shall deem it expedient to raise money by debentures, such debentures shall be issued in London, on behalf of the Government of Ceylon by the Crown Agents, upon the best and most favourable terms that can be obtained, and shall be signed by any one of them on that behalf.</p>
Amount of each debenture.	<p>5 Every debenture issued under the provisions of this Ordinance shall be for the sum of not less than one hundred pounds sterling.</p>
Debentures may be redeemed by annual drawings or by purchase in the market or on a fixed date.	<p>6 The debentures shall be redeemable at par at the option of the Government by purchase in the market, or by annual drawings or on a date to be named in that behalf by the Governor, or by the Crown Agents acting on his behalf, as determined when issuing the debentures, such date not being later than sixty years from the date of issue, from and after which date all interest on the principal money represented thereby shall cease and determine, whether payment of the principal shall have been demanded or not.</p>
Interest coupons.	<p>7 There shall be attached to every debenture coupons for the payment of the interest to become due in each half-year upon the principal represented by the debenture. The coupon shall be sufficient in number to provide for the payment of the interest, either during the whole period for which the debenture has to run, or for such limited period as the Crown Agents, acting on behalf of the Government of Ceylon, may determine.</p>
Form of debentures and coupons.	<p>8 The debentures, and the coupons thereto, shall be in such form as the Governor, or the Crown Agents acting on his behalf, may direct or approve.</p>
Debentures and coupons transferable by delivery.	<p>9 Every debenture and coupon, and the right to receive the principal and interest represented thereby, shall be transferable by delivery.</p>
Registry of debentures.	<p>10 Every debenture shall, before being issued, be registered in a register book to be kept for that purpose at the office in London of the Crown Agents.</p>
Payment of interest.	<p>11 The interest upon the principal represented by each debenture shall run from the day named in that behalf in the debenture, and shall be paid half-yearly on the days named in that behalf in the debenture at the office in London of the Crown Agents.</p>
Mode of providing for payment of interest on debentures.	<p>12 (1) So long as any of the debentures remain outstanding, the Governor shall, in each half-year ending with the day on which the interest on the debentures falls due, appropriate out of the general revenues and assets of the Colony of Ceylon a sum equal to one half-year's interest on the whole of the debentures issued, including any which may have been</p>

redeemed, but exclusive of any which may have been at any time exchanged for inscribed stock, and shall remit that sum to the Crown Agents at such time as will enable them to pay thereout the then current half-year's interest on the day on which it falls due.

(2) Debentures shall not be deemed to be outstanding for the purposes of this Ordinance by reason only that one or more of the debentures have not been presented for payment on the day appointed for payment, and have, in consequence, not been paid.

Further sums to be remitted for the redemption of the debentures.

13 After the date specified in the Ordinance authorizing the loan as that on which the contributions to the sinking fund shall commence, the Governor shall, in each half-year ending as aforesaid, appropriate out of the said revenues and assets of the Colony of Ceylon for the formation of a sinking fund an additional sum equal to one-half of the annual contribution specified in the prospectus, or in the case of a loan not issued publicly, in the terms of issue, relating to the loan, and the said contribution shall be in respect of the total nominal amount of all the debentures issued, including any which may have been redeemed, but exclusive of any which may have been at any time exchanged for inscribed stock, and shall remit that sum to the Crown Agents with the remittance hereinbefore mentioned.

Application of sinking fund.

14 The sinking fund shall be applied in the first place in payment of all expenses of, or incidental to, the redemption of the debentures, and the cost and expenses of all notices required by this Ordinance to be given, and in the next place, and subject to the aforesaid payments, in repayment of the principal moneys for the time being represented by the debentures.

Creation of sinking fund for redemption of debentures payable on a fixed date.

15 In the case of debentures redeemable on a date to be named when issuing the debentures, the Crown Agents shall invest so much of the money so remitted to them as aforesaid as shall not be required for the payment of interest for the current half-year in the purchase of such securities as may be approved by His Majesty's Principal Secretary of State for the Colonies as a sinking fund for the final extinction of the debt, and the Crown Agents shall also invest the dividends, interest, or produce of such investments in the purchase of like securities, and may from time to time, with the approval of the Secretary of State, change any such investments, and shall hold such fund in trust for the repayment of the principal moneys for the time being represented by the debentures.

Disposal of sinking fund when debentures are redeemed by purchase or by annual drawings.

16 In the case of debentures redeemable by annual drawings, the Crown Agents shall place and keep the moneys so remitted to them, or so much thereof as may not be required for immediate payments, at interest, and shall hold all such moneys and the accumulations thereon in trust, to apply them in the first place to the purchase of the debentures when they can be obtained at a price not exceeding par, and secondly, to the redemption of the debentures by means of annual drawings.

Appointment of day for drawing of debentures.

17 After the date specified in the Ordinance authorizing a loan as that on which the contributions to the sinking fund shall commence in respect of that loan, and so long thereafter as any of the debentures remain outstanding and unsatisfied, the Crown Agents shall in every year, unless the whole of the money applicable in that year to the redemption of debentures has been applied in the purchase thereof, appoint a day in that year for the drawing by lot of the debentures to be redeemed.

Notice of time and place appointed for drawing.

18 If a day is appointed for drawing, the Crown Agents shall give, by advertisement in the London *Times* newspaper, not less than fifteen days' previous notice, specifying the day on which, and the hour and place at which, the drawing will take place.

Mode of drawing.

19 On the day and at the hour and place so specified the Crown Agents shall hold a meeting, at which the holder of any debenture may, if he think fit, be present, and shall then in the presence of such debenture holders, if any, as may attend,

- and of a notary public, draw by lot out of the whole number of debentures for the time being outstanding debentures of the specified nominal amount.
- 20** The Crown Agents shall thereupon declare the distinguishing numbers of the debentures drawn for redemption, and shall as soon as may be, by advertisement in the *London Times* newspaper, specify those numbers, and appoint a day, not being later as to each debenture than the day on which the then current half-year's interest thereon is payable, on which the principal moneys represented by the debentures so distinguished will be repaid.
- 21** On the day so appointed the Crown Agents shall, at their office in London, on demand, pay to the holders of the debentures drawn for repayment the principal moneys represented by those debentures, with all interest payable thereon up to that day.
- 22** From and after the day appointed for the repayment of any debenture all interest on the principal moneys represented thereby shall cease and determine, whether payment of the principal shall have been demanded or not.
- 23** Upon the repayment of the principal moneys represented by any debenture, the debenture with all the coupons thereunto belonging shall be delivered up to the Crown Agents, to be by them cancelled and forwarded to the Government of Ceylon. Any debenture redeemed by purchase shall likewise be so cancelled and forwarded.
- 24** When the Governor, or the Crown Agents acting on his behalf, shall deem it expedient to raise money by the issue of Ceylon inscribed stock, then such stock shall be issued in England by the Crown Agents under the provisions of the Act of the Imperial Parliament entitled "The Colonial Stock Act, 1877," upon the best and most favourable terms that can be obtained.
- 25** All the inscribed stock which may be created under the provisions of this Ordinance shall be redeemable at par on a date to be named in that behalf by the Crown Agents when issuing the stock, such date not being later than sixty years from the date of issue, from and after which date all the interest on the principal moneys represented thereby shall cease and determine, whether payment of the principal shall have been demanded or not.
- 26** So long as any of the inscribed stock shall remain unredeemed, the Governor shall, in each half-year ending with the day on which the interest on such inscribed stock falls due, appropriate out of the general revenues and assets of the Colony a sum equal to one half-year's interest on the whole of such inscribed stock, and shall remit that sum to the Crown Agents at such time as will enable them to pay thereout the then current half-year's interest on the day when it falls due.
- 27** After the date specified in the Ordinance authorizing an issue of inscribed stock as that on which the contribution to the sinking fund shall commence, the Governor shall further appropriate out of the said revenue and assets in each half-year ending as aforesaid for the formation of a sinking fund an additional sum equal to one-half of the annual contribution specified in the prospectus, or in the case of a loan not issued publicly, in the terms of issue, relating to the loan in respect of the total nominal amount of such inscribed stock, and shall remit that sum to the Crown Agents with the remittance hereinbefore mentioned.
- 28** The Crown Agents shall, for the purpose of forming such sinking fund, from time to time invest so much of the money so remitted to them as aforesaid as shall not be required for the payment of interest for the current half-year in the purchase of such securities as may from time to time be approved by His Majesty's Principal Secretary of State for the Colonies, and shall also invest the dividends, interest, or produce of such investments in the purchase of like securities, and may from time to time, with the approval of the Secretary of State, change any such investments, and shall hold such fund in trust for repayment of the principal moneys for the time being represented by the inscribed stock.
- Notice of debentures drawn for redemption.
- Payment of drawn debentures.
- Cesser of interest from day appointed for payment of principal.
- Redeemed debentures to be cancelled.
- Borrowing upon inscribed stock.
- When the principal is to be repaid.
- Mode of providing for the payment of interest on inscribed stock.
- Mode of providing for the payment of principal of inscribed stock.
- Creation of sinking fund.



- Charge upon general revenue. **29** In case the sinking funds provided for by this Ordinance shall be insufficient for the payment of all the principal moneys borrowed under the authority of this Ordinance at the time the same shall have become due, the Governor shall make good the deficiency out of the general revenues and assets of the Colony of Ceylon.
- Expenses to be paid out of sinking fund. **30** All expenses of, or incidental to, the management of the sinking fund, or to the payment of the principal moneys borrowed, shall be paid out of the sinking fund.
- Debentures convertible into inscribed stock on conditions prescribed by Crown Agents at time of issue. Conversion of loans generally. **31** The Governor shall also have and may from time to time exercise the following powers and authorities or any of them :
- (a) He may authorize the Crown Agents when issuing any loan in the form of debentures to declare that such debentures will be convertible into inscribed stock at such dates and on such terms and conditions as may be prescribed by the Crown Agents at the time of the issue of the debentures.
- (b) He may declare all or any of the Ceylon loans, whether existing in the form of stock or debentures, to be convertible into inscribed stock to be issued under the provisions of this Ordinance.
- (c) He may authorize the creation and issue of such an amount of inscribed stock in exchange for the securities held for such loans as may be necessary.
- (d) He may authorize the creation and sale of any such inscribed stock or debentures for the purpose of raising money for redeeming any outstanding loans, for paying any expense in the creation of inscribed stock, and otherwise for carrying out the provisions of this Ordinance.
- (e) Any conversion so authorized may be effected either by an arrangement with the holders of existing securities or by purchase thereof out of moneys raised by the sale of inscribed stock, or partly in one way and partly in the other.
- Creation and issue of stock in exchange for other securities. Creation and sale of inscribed stock to raise loans and for other purposes. Arrangements for conversion. **32** Nothing in this Ordinance contained shall authorize an increase of the capital or of the annual charge on any loan, except—
- (a) When securities exchanged for inscribed stock bear a rate of interest not less than the inscribed stock, an additional amount of inscribed stock may be created and issued to make up the difference in saleable value between the securities and the inscribed stock.
- (b) In the case of the conversion of securities into inscribed stock, the Crown Agents shall issue such an amount of inscribed stock as may be required to defray the stamp duties and all other expenses incidental to the conversion.
- (c) In accordance with such terms and conditions as may be prescribed under section 31 (a) of this Ordinance.
- Exchange of securities for inscribed stock. **33** The securities exchanged or otherwise converted into inscribed stock under the provisions of this Ordinance shall be forthwith cancelled by the Crown Agents, and the debentures surrendered shall be cancelled and transmitted to the Governor of Ceylon.
- Converted securities to be cancelled. **34** The trustees of the sinking fund appointed under this Ordinance, and acting under any Ordinance authorizing the issue of any securities which may be exchanged into inscribed stock or cancelled or purchased under the provisions of this Ordinance, shall determine what amount of the sinking fund held by them and created for repayment of such securities shall be released, and in the determination of such question the trustees shall take into consideration the value of the whole investments held by them on account of such sinking funds, the amount of the debt remaining a charge on such sinking funds, and such matters as the trustees may think fit to take into account.
- Trustees to apportion amount of sinking fund released by conversion. **35** So much of the sinking funds as may be released shall either be transferred unto the trustees of the inscribed stock sinking fund, or be disposed of in such a manner as the Governor, with the advice and consent of the Legislative Council, may direct.
- Sinking fund released how to be disposed of.

- Creation, inscription, issue, conversion, and transfer of inscribed stock.
- 36 The Crown Agents may from time to time, at the request of the Governor, make arrangements for all or any of the following things :
- (1) For inscribing stock in their books.
  - (2) For managing the creation, inscription, and issue of inscribed stocks.
  - (3) For effecting the conversion of loans into inscribed stock.
  - (4) For paying interest on inscribed stock and managing the transfers thereof.
  - (5) For issuing inscribed stock certificates to bearer, and as often as occasion shall require re-inscribing them.
- Raising of loans in Ceylon.
- 37 This Ordinance shall be applicable only to the raising of loans in England, and nothing in this Ordinance contained shall prevent the raising of loans in the Colony upon such terms and conditions as shall be specified in any Ordinance authorizing the raising of such loans.
- Repeal.
- 38 "The General Loan and Inscribed Stock Ordinance, 1907," is hereby repealed.
- Saving clause.
- 39 Nothing in this Ordinance, or in the repeal of Ordinance No. 19 of 1884, or of "The General Loan and Inscribed Stock Ordinance, 1907," shall affect the rights of any person who holds stock or bonds under the authority of Ordinance No. 19 of 1884, or of "The General Loan and Inscribed Stock Ordinance, 1907."
- Short title.
- 40 This Ordinance may be cited as "The General Loan and Inscribed Stock Ordinance, No. of 1921."

*Statement of Objects and Reasons.*

THE preamble to Ordinance No. 22 of 1907 recites that it is expedient to define in one Ordinance the terms and conditions applicable to loans authorized to be raised by the Colonial Legislature. By Ordinance No. 28 of 1914 certain amendments were made in the principal Ordinance; and certain further amendments are required to be made so as to allow of a loan being floated in London.

It has been thought advisable to repeal Ordinances No. 22 of 1907 and No. 28 of 1914 with a view to re-enactment of these provisions with the necessary amendments; and this is proposed to be effected by this Bill.

The Bill largely consists of a re-enactment of the provisions of No. 22 of 1907, with the following changes :—

- (a) In sections 3, 6, 18, 25, 26, 31 (d), 32, 36, 38, 39, and 40 of the Bill the amendments required by Ordinance No. 28 of 1914 have been made.
- (b) Section 12 (2) of the Bill is new, and has been added on the direction of the Secretary of State with the object of defining the expression outstanding debentures.
- (c) In section 13 of the Bill an amendment has been introduced, on the direction of the Secretary of State, allowing of the contribution to the sinking fund being based with reference to the prospectus of the terms of issue.
- (d) Section 24 of No. 22 of 1907 provides that the interest on stock raised under that Ordinance shall not exceed 4 per cent.; this provision does not appear in section 24 of the Bill. It would obviously be impossible under existing conditions to raise a loan at such a rate of interest.
- (e) In section 27 of the Bill an amendment similar to that in section 13 of the Bill has been made and for the same reason.

## MINUTE.

The following Draft of a proposed Ordinance is published for general information :—

**An Ordinance to make provision for a Loan of Six Million Pounds Sterling for the Construction of certain Public Works and other purposes.**

Preamble.

WHEREAS it is expedient to raise a loan of six million pounds sterling for the purposes specified in the schedule hereto: Be it therefore enacted by the Governor of Ceylon, by and with the advice and consent of the Legislative Council thereof, as follows :

Short title.

1 This Ordinance may be cited as "The Public Works Loan Ordinance, No. of 1921."

Authority

stock.

2 (1) The Governor is hereby authorized to issue stock or debentures, or both, under the provisions of "The General Loan and Inscribed Stock Ordinance, No. of 1921," to an amount sufficient to produce, as nearly as may be, the sum of six million pounds sterling, to be appropriated and applied to the purposes specified in the schedule hereto, and such further sum as may be necessary to defray the expenses of issue, provided that no expenditure shall be incurred in respect of the tenth item in the schedule hereto, until such expenditure shall have been approved by a resolution of the Legislative Council and by the Secretary of State.

(2) It shall be lawful for the Governor to direct that any sums which may not be required for a purpose specified in the schedule may be appropriated and applied to any other purpose therein specified:

Provided that no such transfer of money from one item of the schedule to any other item thereof shall be made, unless such transfer shall first have been approved by a resolution of the Legislative Council and by the Secretary of State.

Commencement  
of contribution  
to sinking fund.

3 The contributions to sinking fund, as contemplated by sections 13 and 27 of "The General Loan and Inscribed Stock Ordinance, No. of 1921," shall commence after the expiration of three years from the date on which the interest on the first debentures or inscribed stock to be issued under this Ordinance shall begin to run.

Repeal.

4 The borrowing powers created by Ordinance No. 6 of 1909, except to the extent to which they have been already exercised at the date of the commencement of this Ordinance, shall as from such date cease to be operative.

*Statement of Objects and Reasons.*

THE object of the Draft Ordinance is to authorize the raising of a loan of £6,000,000.

2. The money raised is to be applicable to the purposes detailed in the schedule.

3. The first charge on the loan will be the repayment of the advances already made by the Colony to the Municipal Council, Colombo, for drainage and waterworks, amounting approximately to Rs. 14,200,000.

4. After deducting the sums of Rs. 14,200,000 from the total amount to be raised, viz., Rs. 60,000,000, there remains a balance of Rs. 45,800,000 available for the items in the Loan Schedule. Of this sum, items 2, 3, 4, 5, 6, 7, 8, and 9 absorb Rs. 30,990,000, leaving a balance of Rs. 14,810,000, which it is proposed to utilize for various public works which are of pressing importance, viz., the completion of the Government housing scheme, of various roads, the construction of bridges and buildings, and the carrying out of certain further small railway extensions. These works have been included in the Loan Schedule under one head: "Other Works of Development." None of these works, however, will be carried out without the previous authority of the Legislative Council.

5. On a basis of a 6 per cent. loan and sinking fund at 1 per cent., the amount to be voted annually in respect of this loan will be Rs. 4,200,000.
