Rules

The Rule of the Post and Telegraph Benefit Association published in *Gazette* No. 9936 of January, 07, 1949 as amended from time to time, are hereby further amended as follows:-

(01) Chapter 1 - General Rules

The paragraphs (a), (b) and (c) of the Rule 19-3-1 may be deleted and the following paragraphs may be substituted.

- (a) A loan amounting to Rs. 20,000 shall be paid to a person who was a member of the Association for more than 02 years and less than 05 years;
- (b) A loan amounting to Rs. 30,000 shall be paid to a person who was a member of the Association for more than 05 years and less than 15 years;
- (c) A loan amounting to Rs. 50,000 shall be paid to a person who was a member of the Association for more than 15 years;

(02) Chapter V - Loan for marriage

The words “maximum amount of loan amounting to Rs. 10,000 close to the marriage of every member” may be deleted and the following paragraph may be substituted:

1. Every member shall be entitled to obtain a maximum loan for marriage amounting to Rs. 100,000 close to the marriage of every member or his/her child. The certificate of marriage shall be forwarded within one month after obtaining the loan.

However, Committee may approve a loan for marriage within a period of 12 months with effect from the date of marriage, only if strong reasons have been adduced. This loan will be get levied in 40 instalments valued at Rs. 2,750 per each instalment. (An additional amount of Rs. 250 is as service charge.),

In the event of failure to get levied monthly instalments as specified, an additional charge of a sum of Rs. 125 for each month defaulted shall be recovered;

(03) Chapter VII - Loan for the purchase of Special Items.
Rule 1-3-11

The words “One Hundred Thousand Rupees (Rs. 100,000)” for the purchase of special items may be deleted and the words “Two Hundred Thousand Rupees (Rs. 200,000)” may be substituted:

1. A loan amounting to Rs. 200,000 shall be granted for the purchase of the under mentioned items;
2. If the value of the item purchased is over Rs. 200,000 the amount in excess shall be paid by the member;

(04) Chapter VIII - Festival Advance Loan

- 1 and 2 - The words “Rs. 50,000 for Festival Advance loan may be deleted and Rs. 60,000 may be substituted. The words “10 monthly instalments” of Festival Advance loan may be deleted and the words “12 instalments” may be substituted.

1. A loan of festival advance not more than Rs. 60,000 for every member on a request shall be granted per calendar year.
2. The loan of festival Advance shall be get levied in 12 instalments. A service charge of 10% of the monthly instalment shall be recovered in addition to the monthly instalment.
