NOTIFICATIONS.

Order No. 89 made by the Food Controller under Regulation 1 of "The Defence of the Colony Regulations, 1919."

Order No. 76 made by the Food Controller, published in *Government Gazette Extraordinary* No. 7,186 of June 30, 1921, and Order No. 87 made by the Food Controller, published in *Government Gazette Extraordinary* No. 7,190 of July 5, 1921, are cancelled as from the date of commencement of this order.

2. From and after the date of commencement of this order no rice of the kinds shown in the attached schedule shall be sold or offered for sale at the Chalmers Granaries at a price exceeding that shown in the schedule in respect of each kind of rice.

3. Every bag so sold shall be a measured bag containing the number of bushels specified in the attached schedule.

4. The scheduled prices shall include delivery into railway wagons within the premises of the Granaries or into carts at the doors of the Granaries' stores. The rice merchants shall be entitled to charge 5 cents per bag over and above the controlled prices if they are required to deliver consignments at the Maradana or Kelani Valley Goods Sheds.

5. A rebate of 12 cents a bag shall be allowed by the rice merchants for all cash payments.

6. This order shall commence and come into operation from July 9, 1921, and shall be in force up to and including July 31, 1921.
