THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, John Anthony Emmanuel Amarathunga, Minister of Lands, hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act.

The allotment of land shown as "Bo Gaha Yata Pela, Assmnt. No.595/1, William Gopallawa Mawatha" in total extent of about 0.0350 Hectares, depicted in Advance Tracing No. Maha/MHN/2015/711 dated 19.01.2016 prepared by the Surveyor - General, situated in the Village of Peradeniya in Wel Ata Ward No. 1 (within the Kandy Municipal Council Limits) in Minor Division of Gangawata Korale in the Divisional Secretary's Division of Kandy Four Gravets and Gangawatakorale in Kandy District in Central Province and bounded as follows:
