I hereby give notice to the public under Sub - section (1) of Section (7) of the Land Acquisition Act, as amended by Land Acquisition Act (amendment) No. 28 of 1964, the land described below is required by the government and the Government intends to acquire the said land/ servitude for a public purpose.
