### Land Acquisition Notices

#### THE LAND ACQUISITION ACT (CHAPTER 460)

##### Declaration under Section 5

I, John Anthony Emmanuel Amarathunga, Minister of Lands, hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, that the lands described below are needed for a public purpose and will be acquired under the provisions of that Act.

The allotments of land (Lots 22) in total extent of about 3.3523 Hectares, depicted in Advance Tracing No. H/ANG/RDA/2016/601 and dated 18.08.2016, prepared by the Senior Superintendent of Survey on behalf of the Surveyor - General, situated in the Village of Netalaporuwa (FVP 253) in the Grama Niladhari Division of No. 200, Idigatawela in Minor Division of East Giruwa Paththuwa in the Divisional Secretary's Division of Angunakolapelessa in Hambantota District in Southern Province and bounded as follows:
