NOTIFICATION.

Order No. 75 made by the Food Controller under Regulation 1 of "The Defence of the Colony Regulations, 1919."

1. Order No. 68 made by the Food Controller, published in *Government Gazette* No. 7,118 of July 23, 1920, is hereby cancelled.

2. From and after the date of commencement of this order, no rice of the kinds shown in the attached schedule shall be sold or offered for sale at the Chalmers Granaries at a price exceeding that shown in the schedule in respect of each kind of rice.

3. This order shall commence and come into operation from December 16, 1920.

4. Until the present stocks of rice are exhausted, sales from the Chalmers Granaries and the Manning Markets will continue to be made only on orders issued by the Deputy Food Controller, Chalmers Granaries, strictly in accordance with priority of shipment.

5. Exports of rice from Burma are not permitted, except on license from the Rice Commissioner. Licenses for import into Ceylon will also be required from the Food Controller, Colombo, and may be applied for at once.

6. Applicants for licenses to import rice will be required to forward a signed statement to the effect that the rice to be imported by them will not be sold or issued by them for consumption until the present stocks of rice in the Chalmers Granaries and Manning Markets are exhausted. If the rice is to be stored in Colombo outside the Chalmers Granaries and Manning Markets, they will also forward a certificate from the Chairman of the Plague Committee that their stores conform to the requirements of the Plague Committee. If it is to be stored within a Municipality or Local Board, their applications will be forwarded through the local authority to be countersigned with his approval. All applications will state the quantity which it is desired to import and where it will be stored.
