WHEREAS by a Proclamation dated the 29th day of April, 1921, and published in the Government Gazette of the 6th day of May, 1921, His Excellency the Governor, under the provisions of clause 58 of "The Ceylen (Legislative Council) Order in Council, 1920," appointed that the first session of the Legislative Council should be held in the Council Chamber, Colombo, and that the first sitting thereof should begin at 2.30 P.M. on Tuesday, the 7th day of June, 1921 :

WHEREAS by clause 58 of "The Ceylon (Legislative Council) Order in Council, 1920," it is enacted that the sessions of the Legislative Council constituted by the said Order shall be held at such times and places as the Governor shall from time to time, by Proclamation in the *Government Gazette*, appoint :

Know Ye that We, the Governor, do hereby appoint that a session of the said Council shall be held in the Council Chamber, Colombo, and that the first sitting thereof shall begin at 2.30 P.M. on Thursday, the 8th day of June, 1922.

Given at Nuwara Eliya, in the said Island of Ceylon, this Sixteenth day of May, in the year of our Lord One thousand Nine hundred and Twenty-two.
