Miscellaneous Lands Notices

The Notice No. 09-218 which was published in the Gazette No. 1984 dated 09.09.2016 has now to be amended as follows :

NOTIFICATION MADE UNDER STATE LAND REGULATION No. 21 (2)

IT is hereby notified that for the purpose of Commercial, National Aquaculture Development Authority of Sri Lanka has requested on lease a State land containing in extent about 01 Acre out of extent marked in the Tracing and situated in the village of Olaithoduwai with belongs to the Grama Niladhari Division of MN/60 Olaithoduwai coming within the area of authority of Mannar town Divisional Secretariat in the District of Mannar.

02. Given below are the boundaries of the land requested :

On the North by: State Land ;

On the East by : State Land ;

On the South by: Sea shore ;

On the West by : Road.

The land requested can be given on lease for the necessary purpose. Therefore, the Government has intended to lease out the land subject to other Government approved conditions:-

(a) *Terms of the Lease.*- Thirty (30) Years , (from 30.06.2016 to 29.06.2046);

The Annual Rent of the Lease.-4% of the commercial value of the land as per valuation of the Chief Valuer for the Year 2016. This amount of the lease must be quinquennially revised in such a manner that the amount as a result of the revision will be not less than 50% of the amount that just preceded.

Premium .- Three times of the annual rent of the lease ;

- (b) The lessee must, within one year of the commencement of the lease, develop the said land, in such a manner as to captivate the mind of the Divisional Secretary ;
- (c) The lessee must not use this land for any purposes other than for the purpose of Commercial Activities;
- (d) This lease must also be subject to the other special conditions stipulated and imposed by the Divisional Secretary/Scoping Committee/ Board of Investment of Sri Lanka and by other institutions;
- (e) The buildings constructed must be maintained in a proper state of repair.
- (f) Once the land is given on lease and in the event of failure on the part of the lessees to substantiate within the specified time frame the purpose for which the land was obtained, action will be taken to terminate the lease ;
- (g) No sub - leasing can be done until the expiry of a minimum period of 05 years form 06.05.2016 ;
- (h) Payment of the lease must be regularly made and if defaulted in payment, the agreement will *ipso facto* lapse.

If acceptable reasons are not submitted to me in writing within six weeks of the date herein below to the effect that this land must not be given on lease, the land will be leased out as requested.
