PROCLAMATIONS BY THE GOVERNOR.

IN the Name of Her Majesty VICTORIA, of the United Kingdom of Great Britain and Ireland Queen, Defender of the Faith.

PROCLAMATION.

By His Excellency Sir ARTHUR ELIBANK HAVELOCK, Knight Commander of the Most Distinguished Order of Saint Michael and Saint George, Governor and Commander-in-Chief in and over the Island of Ceylon, with the Dependencies thereof.

WHEREAS by the 6th section of "The Masters Attendant Ordinance, 1865," it is enacted that the Governor may from time to time, with the advice and consent of the Executive Council, frame and establish such port rules, not inconsistent with the said Ordinance, as he may think necessary for the purposes specified therein, provided that such port rules shall be promulgated by Proclamation in the *Government Gazette* at least one month before the same shall take effect:

And whereas the Port of Colombo was brought within the operation of the said Ordinance by a Proclamation dated 6th January, 1866, on which day the Governor, with the advice and consent of the Executive Council, did also frame and establish certain Port rules for the port of Colombo, and duly promulgate the same by Proclamation in the *Government Gazette* of January 6, 1866:

And whereas new port rules were made and established for the Port of Colombo, for the purposes of the said Ordinance, by Proclamation bearing date the 24th August, 1882:

And whereas by the 1st section of the Ordinance No. 23 of 1884 it is further enacted that whenever by any law or Ordinance of this Colony power is given to "the Governor in Executive Council," or to "the Governor with the advice of the Executive Council," or to "the Governor with the advice and consent of the Executive Council" to make any rules or regulations under such Law or Ordinance, such power shall be deemed to include the power of altering, amending, adding to, or repealing any rules or regulations so made:

And whereas it is expedient to amend the Port rules promulgated by the Proclamation of 24th August, 1882:

Now know Ye that We, the said Governor, with the advice and consent of the Executive Council, do by this Our Proclamation promulgate the following amended port rules for the Port of Colombo as required and directed by the said Ordinance.

Given at Colombo, in the said Island of Ceylon, this Twentieth day of December, in the year of our Lord One thousand Eight hundred and Ninety-four.

RULES RELATING TO THE PORT OF COLOMBO.

Vessels on arrival to be reported at Custom-house and Master Attendant's Office.

1. Commanders of all vessels arriving within the port, or their agents, shall report their vessels without delay at the Custom-house and Master Attendant's Office, and furnish the Master Attendant with a list of their passengers disembarking and embarking, and twelve hours before sailing hoist a Blue Peter at the fore, and give notice at the Master Attendant's Office of the time of sailing.

Mails to be landed without delay.

2. Commanders of all vessels arriving within the port shall, without delay, deliver to the pilot boat, or other boat sent for the purpose, or land in their own boat, all mail-packets or letters intended for the port.

Vessels to take up the berth appointed for them.

3. All vessels within the port shall take up the berth appointed for them by the Master Attendant, and shall change their berth, or remove, whenever he requires them to do so.

Vessels not to change berth without permission.

4. No vessel within the port shall change her berth, or remove, without permission from the Master Attendant, except in cases of emergency.

No communication to be held until vessel is passed by port surgeon.

5. No person shall leave, and no person except a pilot shall go on board of any vessel arriving within the port that has not a qualified medical officer, until the port surgeon or health officer has given permission to do so.

Vessels carrying a doctor may communicate, provided no sickness on board.

6. Any person may leave or go on board of any vessel arriving within the port having a qualified medical officer, upon a certificate being given by that officer to the pilot that such vessel is at the time of her arrival free from all contagious or infectious disease, and that she has been free from such during the voyage.

Vessels in quarantine to anchor in outer roads.

7. Any vessel arriving within the port liable to be placed in quarantine shall not come within the harbour, but shall cast anchor in the outer roads in the place appointed by the Master Attendant for quarantine anchorage; and any vessel within the harbour placed in quarantine shall immediately be removed to the quarantine anchorage in the outer roads aforesaid; but with the approval of the port surgeon vessels quarantined may come into the harbour and remain there. All vessels in quarantine shall display the following signals: by day the quarantine flag at the fore, and by night a red light over a white light six feet apart hoisted well up where best seen. All vessels arriving within the port that have not a qualified medical officer on board shall display the quarantine signal until the port surgeon has given pratique.

Persons dying on board to be interred on shore.

8. If any person die on board of any vessel within the port, the commander thereof shall cause the body to be brought on shore and interred or otherwise disposed of under directions of the port surgeon.

Infectious cases not to be landed.

9. No person suffering from an infectious disease shall be landed from any vessel within the port without the consent of the port surgeon.

Dead animals not to be thrown overboard.

10. No dead animal shall be thrown overboard from any vessel or boat within the harbour, or within a radius of one mile from the Breakwater head.

Ballast or rubbish not to be thrown overboard.

11. No ballast, ashes, or rubbish shall be thrown overboard from any vessel or boat within the port under a depth of twelve fathoms water.

Vessels to be moored head and stern.

12. All vessels within the harbour shall be moored head and stern as soon as possible after arrival, and shall remain so moored until they are ready to sail.

Spars, &c. to be removed when required.

13. All vessels within the harbour shall keep their jib and spankerbooms rigged in, and shall strike yards and masts, and shall remove any anchor, spar, or any other article projecting from their sides, when required to do so by the Master Attendant.

Warps to be made fast when required.

14. Warps shall be made fast to any vessel within the port if required for the purpose of assisting any other vessel in mooring or shifting its berth, and shall be kept fast until required to be let go by the officer in charge of the vessel mooring or shifting.

- Vessels and boats not to anchor in the channel.
- Wharves and jetties to be kept clear.
- Particular cargoes to be discharged in particular berths.
- Tarpaulins required when coaling and ballasting.
- Coal to be discharged in special shoots.
- Vessels, &c., not to be fast to buoys other than mooring buoys.
- Pitch, &c., not to be heated on board.
- Vessels with more than 5 cwt. of explosives on board not to enter harbour.
- Vessels requiring to be graved to be removed to a special place.
- Customs working hours.
- Supply of spirits prohibited.
- Anchor light.
- Signals.
- Rates of pilotage.
- Pilot signals.
- Boats receiving coal to have special bulwarks.
- Boats to be kept under shoots.
- Boats to have a tindal always on board.
- Boats not to communicate with shore except at authorized jetties.
15. No vessel or boat shall anchor in the entrance of the harbour, or in the channel leading to or from any of the mooring buoys within the harbour.
16. Free passages shall be kept to all piers, jetties, wharves, or landing-places, and all vessels or boats shall move when required to clear such passages.
17. All vessels taking in, or discharging ballast or any particular kind of cargo within the harbour, shall take up such berth as may be appointed for the purpose by the Master Attendant.
18. Tarpaulins properly stretched and spread between the side of the ship and the lighter shall be used by all vessels within the harbour in shipping or discharging ballast or coal, so as to prevent any part thereof from falling overboard.
19. All vessels commencing to discharge coal in bulk by open shoots shall use shoots of not less than 4 feet in breadth with sides of 1 foot in depth and of sufficient length to reach down to a point not more than 4 feet above the gunwales of the lighter receiving the coal; but when the vessel shall have been lightened of about half her cargo, an extra length of shoot of from 6 to 8 feet shall be attached to the ends of the shoots in use.
Telescopic shoots of the above breadths and lengths may be used instead of open shoots.
Vessels discharging ballast shall also make use of similar shoots to the above.
20. No vessel, boat, raft, or any other article shall be made fast to any buoy, beacon, or sea-mark within the port, except buoys intended for the purpose.
21. No vessel within the harbour shall boil or heat any pitch, tar, resin, dammar, turpentine, oil, or any other such combustible matter on board, but may do so when required in a boat alongside.
22. All vessels, except vessels belonging to Her Majesty or any Foreign Power, arriving within the limits of the port, and having on board more than 5 cwt. of gunpowder or any other explosive substance, shall not enter the harbour until the same shall have been discharged from the vessel, unless such gunpowder or other explosive substance is stored securely in a ship's magazine properly constructed.
23. All vessels within the harbour requiring to be graved, breamed, or smoked shall be moved to a berth set apart for that purpose by the Master Attendant.
24. No vessel within the port shall land or ship cargo before 6 A.M. or after 4 P.M. without permission from the Collector of Customs.
25. No person shall sell, supply, or convey any wine or spirituous liquors to any of the crew, or to any other person on board of any vessel within the port, without the consent of the commander of such vessel.
26. All vessels at anchor within the port shall exhibit between sunset and sunrise, where it can be best seen, but at a height not exceeding 20 ft. above the hull, a white light in globular lantern of 8 in. in diameter, and so constructed as to show a clear, uniform, and unbroken light visible all round the horizon, but at a distance of at least one mile.
27. No vessel within the port shall fire guns or rockets or burn blue lights, between the hours of sunset and sunrise, excepting the mail steamers on arrival, which may make such signals as may be arranged with the Master Attendant, and vessels in distress, which should make any of the Board of Trade distress signals.
28. All vessels over 200 tons entering the port of Colombo shall pay pilotage at the following rates, which shall cover them both inwards and outwards:—

- Vessels liable to pay pilotage shall, on entering and leaving the port in charge of a pilot between the hours of 6 P.M. and 6 A.M., pay in addition to the above rates an extra fee of Rs. 15, Rs. 10 of which shall go to the pilot and Rs. 5 to the boat's crew.
29. Vessels inward bound requiring a pilot should display the Board of Trade pilot signal, and vessels outward bound requiring a pilot should hoist the jack at the fore by day, and by night two red lights 6 ft. apart hoisted well up where best seen.
30. No boat or lighter shall receive loose coal or ballast from shoots from vessels within the harbour without having a temporary bulwark of planks or sheet iron, 2 ft. high by 12 ft. long, shipped on the gunwale of the lighter on the offside whilst being loaded, so as to prevent any part thereof from going overboard from the boat; and no lighter shall be loaded with loose coal heaped up above the gunwales.
31. The tindal and boatmen of boats or lighters employed in receiving loose coal or ballast from shoots from vessels within the harbour shall keep their boats or lighters fairly under the shoots, whilst being loaded, so as to prevent any part thereof from going overboard.
32. No licensed boat or canoe shall land or ship cargo or passengers from or to any vessel within the port without a licensed tindal being in charge.
33. No licensed boat or ship's boat, other than those actually engaged in landing or shipping coal, shall be allowed to communicate with the shore within the limits of the port, except at the authorized jetties within the Customs premises, unless specially authorized by the Master Attendant or the Collector of Customs.

Boats to be moored in special places.

Boats not to be beached without permission.

Boats not to be alongside of jetties.

Boats not to go alongside before vessel is moored.

Boats not to lie alongside of vessels.

Boats to keep out of the course of vessels under weigh.

Notice to be given of withdrawal of boats from work and return to work.

Notice of change of ownership to be given.

Number of persons licensed to carry, and fare, to be painted.

Passenger boats to be employed in rotation.

A certain number of boats to be kept ready for service at night.

Steam whistles not to be sounded by vessels between 9 P.M. and 6 A.M. except those under weigh.

Vessels losing moorings between 9 P.M. and 6 A.M. to burn a blue light at intervals till the pilot boards.

Vessels requiring urgent assistance to fire a rocket in addition to the blue light.

All persons to be prohibited from descending into holds till purity of air has been tested.

All steam launches, tugs, and steam water boats when under weigh between sunset and sunrise to carry regulation lights for steamers.

All cargo boats and coal boats when under weigh to carry a combined green and red light.

All passenger rowing boats, canoes, and private rowing boats to have a white light at hand to show in time to prevent collision.

All sailing vessels to carry regulation side lights when under weigh.

34. All boats and canoes within the harbour when unemployed shall be moored or hauled up in the places appointed for the purpose by the Master Attendant.

35. No vessel, boat, or canoe shall be hauled up on any part of the beach within the harbour without permission from the Master Attendant.

36. No boat or canoe shall be alongside of any wharf, jetty, or landing-place within the harbour longer than is necessary to land or ship passengers and their luggage or cargo, but shall lie off at a distance so as not to obstruct the approach thereto.

37. No boat or canoe shall go alongside, or within 50 fathoms of any vessel arriving within the port, until such vessel has been moored in her berth.

38. No boat or canoe shall lie alongside of any vessel within the port longer than is necessary to embark or disembark its passengers and luggage, but shall lie off at a distance of not less than 15 fathoms from the ship's side, so as to leave a clear passage to and from the gangway.

39. All boats, canoes, and kattamarams shall keep out of the course of steamers and sailing vessels entering or leaving the harbour, and of the mooring boats employed in passing lines to the buoys, so as not to impede or obstruct their movements.

40. No licensed boat or canoe shall be withdrawn from the port or from work without notice being given to the Master Attendant. Notice shall also be given of the return to the port or to work of any boat or canoe that has been withdrawn.

41. Notice of transfer of ownership of any licensed boat or canoe shall be given to the Master Attendant, and the transfer endorsed on the license.

42. The number of persons a boat or canoe is licensed to carry, and the fare, shall be legibly painted on the backboard or some other conspicuous place.

43. All licensed boats and canoes plying for passengers shall be employed strictly in rotation, and the order of rotation shall be regulated by the tindals appointed for that purpose by the Master Attendant.

44. A certain number of the licensed boats and canoes plying for passengers, as may be from time to time notified by the Master Attendant, shall be kept ready for service at night and on Sundays and holidays.

45. No vessel within the port shall sound any kind of steam whistle for any purpose whatever between the hours of 9 P.M. and 6 A.M., except vessels when under weigh, either in entering or leaving the harbour.

If a vessel between these hours lose her moorings, a blue light should be burnt at intervals till a pilot boards the vessel to re-moor her.

If between these hours a vessel requires urgent assistance, she should fire a rocket in addition to the blue light. As soon as either of the above signals are seen at the flagstaff, a blue light will be burnt in answer from the pilot station.

46. All persons shall be prohibited by the commanders of vessels from descending into the holds after removal of the hatches, till the air in the holds has been tested and found respirable. If a naked light lowered into the depths of the hold is not extinguished, the air is pure.

47. All steam launches, tugs, and steam water boats shall, when under weigh between sunset and sunrise, carry in the forepart of the vessel, or on or in front of the funnel where it can best be seen, a bright white light so constructed as to show the light from right ahead to two points abaft the beam on each side, and shall also carry the regulation side lights, green on the starboard side and red on the port; or a combined lantern showing a green light and a red light from right ahead to two points abaft the beam on their respective sides. Such lantern shall be carried below the line of the bright light. Steam launches shall also, between the times specified, proceed at a moderate speed.

48. All cargo boats and coal boats, whether laden or empty, shall, when under weigh between sunset and sunrise, carry in the forepart of the boat, where it can best be seen, a lantern with a green glass on one side and a red glass on the other, so fitted that the green light shall not be seen on the port side nor the red light on the starboard side.

49. All passenger rowing boats and canoes and private rowing boats shall, when under weigh between sunset and sunrise, have ready at hand a lantern showing a white light, which shall be temporarily exhibited in sufficient time to prevent collision.

50. All sailing vessels shall, when under weigh within the limits of the port between sunset and sunrise, carry the regulation side lights, green on the starboard side and red on the port side.

Signals to be used by vessels requiring assistance of harbour police.

Cargo boats not to lie in tiers of more than four boats abreast.

Logs of timber not to be discharged over side of vessel into the water without permission of Master Attendant.

Commanders or commanding officers and owners or tindals of boats held responsible for any breaches of rules.

51. The following signals should be displayed by vessels requiring the assistance of the harbour police: by day the ensign hoisted at the main, and by night two white lights with a red light between them six feet apart, hoisted well up where best seen.

52. Cargo boats shall not lie alongside of any vessel in the harbour in tiers of more than four boats abreast.

The tindal or person in charge of any boat or boats found lying outside of the fourth boat from the vessel's side shall be liable to prosecution for breach of this rule.

53. No vessel within the port shall discharge logs of timber over the side into the water for the purpose of being floated ashore, unless the special permission of the Master Attendant shall have been obtained therefor, and a guarantee given for the fulfilment of the measures required by him for preventing such timber becoming a source of danger or impediment to the navigation of the harbour.

54. Commanders or commanding officers of vessels, and owners or tindals of boats, shall be held responsible for any breaches of these rules occurring on board of their vessels or boats, respectively, and accordingly may be prosecuted for the same unless the actual guilty party or parties be delivered up.

HIS EXCELLENCY THE LIEUTENANT-GOVERNOR has been pleased to direct the publication of the following Amended Colonial Regulations :—

125. Governors are to furnish every officer proceeding on leave of absence with a duplicate of the certificate above-mentioned ; and an absent officer must produce such certificate to the Crown Agents for the Colonies in order to receive his salary. A third copy of the certificate should be transmitted by the Colonial Government direct to the Crown Agents for the Colonies when the officer's salary is to be paid through them, with instructions to issue the salary accordingly as it becomes due.

130. On arriving in this country the officer on leave must report his arrival by letter to the Colonial Office, mentioning the place of his residence ; and he must similarly notify any subsequent change of residence. Treasurers and Auditors of Colonies, whose accounts are subject to Imperial Audit, should also send their address to the Comptroller and Auditor-General.—(Enclosure to Circular Despatch of the 30th November, 1880.)

The Earl of Kimberley, Her Majesty's Principal Secretary of State for Foreign Affairs, has received from Her Majesty's Minister at Tôkiô the following translation of an Imperial Ordinance promulgated by the Japanese Government on August 20 last, concerning the examination of prizes of war and the establishment of Prize Courts in Japan :—

IMPERIAL ORDINANCE No. 149.

CHAPTER I.

Organization and Competence of Prize Court and Higher Prize Court.

Article 1.—Matters concerning prizes of war shall be examined in first instance by the Prize Court, and in second instance by the Higher Prize Court.

Article 2.—In the Prize Court there shall be appointed one President and six Councillors.

The President shall be appointed from the Judges of Court of Appeal.

Of the Councillors, one shall be appointed from officers of the Imperial Navy, two from Judges, one from the Naval Judges, one from the Councillors of Board of Legislation, and one from the Councillors or Secretaries of the Department of Foreign Affairs.

Article 3.—In the Higher Prize Court there shall be appointed one President and eight Councillors.

The President shall be appointed from the Privy Councillors.

Of the Councillors, one shall be appointed from the Privy Councillors, two from the Admirals, and three from the Judges of Supreme Court, and the remaining two shall be the President of Board of Legislation and the Director of the Political Bureau in the Department of Foreign Affairs.

Article 4.—The Presidents of the Prize Court and Higher Prize Court shall respectively superintend the affairs of the Courts, and personally preside over the examinations. Should the President be prevented from discharging his duties, he may detail one of the Councillors of the respective Courts to represent him at the examinations.

Article 5.—In both the Prize Court and the Higher Prize Court there shall be appointed two Procurators.

The Procurators of the Prize Court shall be appointed from public Procurators, and those of the Higher Prize Court from high administrative officers.

Article 6.—The Presidents, Councillors, and Procurators of the Prize Court and Higher Prize Court shall be appointed by the Minister President of State, with Imperial sanction.

Article 7.—Clerks shall be appointed in the Prize Court and Higher Prize Court.

The clerk shall be of Hannin rank, and shall be appointed by the respective Presidents.

Article 8.—The examination and decision shall be made by a collegiate body in case of the Prize Court, of not less than five members, consisting of the President and Councillors, and in case of the Higher Prize Court, of not less than seven members, consisting of the President and Councillors.

Article 9.—The opening and closing of the Prize Court and Higher Prize Court shall be determined by special Imperial Ordinance.

The higher Prize Court shall sit in Tōkiō, but the seat of the Prize Courts shall be determined by Imperial Ordinance.

CHAPTER II.

Proceedings of the Examination of Prizes of War.

Article 10.—The officer in command of a war vessel or a vessel having made a capture shall bring the captured vessel to the port where the Prize Court is situated, or he shall place a Prize Master on board the captured vessel, and let him bring the same to such port, and immediately on arrival there a written statement shall be forwarded to the Court.

This statement shall contain the reasons for the capture, and all the facts to prove legality of that action, and it shall be accompanied by all the books and papers received by the master or crew of, or found on board, the captured vessel.

Article 11.—The President of the Prize Court shall, on receipt of the statement mentioned in the preceding Article, name one of the Councillors to take charge of the case.

The Councillor in charge shall open, in the presence of the Commanding Officer or Prize Master and the master of the captured vessel, the seal of the documents produced, and make a list of them.

Article 12.—The Councillor in charge shall hear the verbal statements of the master and crew of the captured ship, and, if deemed necessary, the statements of the crew of the ship which has made the capture, as well as of the passengers on board the captured ship, and cause the clerk to take minutes thereof.

Article 13.—The Councillor in charge shall, after the examination of facts deemed necessary for determining whether the whole or a part of the capture shall constitute a prize or be released, draw up a written report and forward the same to the Procurator of the Court, together with the report and accompanying papers mentioned in Article 10.

Article 14.—The Procurator shall draw up a memorial in respect to the examination and lay the same before the Prize Court, together with all the documents forwarded to him.

The Procurator may designate those points of fact which are deemed necessary for drawing up his memorial, and ask the Councillor in charge to make a special investigation thereof.

Article 15.—When the Procurator recommends in his memorial the immediate release of the capture, and the Prize Court also deems it proper, the Court shall draw up a written decision to that effect and hand it to the Procurator.

Article 16.—In case the Procurator recommends in his memorial that the capture be adjudged a prize, as well as in case the Prize Court regards as improper the memorial of the Procurator recommending the immediate release of the capture, the Court shall take steps to issue a notification.

Such notification shall be published in the official *Gazette*, and it shall state that any person who regards his interest as injured in consequence of the capture being pronounced a prize may send in a written petition within thirty days from the day following the notification.

When no such petition is sent in within the period prescribed in the preceding clause, the Prize Court shall immediately proceed with the examination; provided, however, that on application of the Procurator the decision be rendered immediately without the process of examination, and the written decision shall be delivered to the Procurator.

Article 17.—The written petition shall contain the principal points of the prayer, and be accompanied by the documents and objects serving as proofs thereof.

Article 18.—When a petition is sent in within the period prescribed in Article 16, a time shall be appointed for oral examination, and the Procurator and the petitioner shall be required to make their statements. The petitioner may employ Japanese advocates to plead his cause.

When the oral examination is completed, the decision shall be pronounced either immediately or at a future time specially appointed. The absence of the petitioner shall not cause the postponement of the decision.

Article 19.—In case a further examination of evidence is required by the Prize Court during the proceedings, such examination may be ordered to the Councillor in charge.

The Procurator and petitioner may, during the proceedings, produce new facts and proofs.

Article 20.—Beside the foregoing, rules relating to the proceedings of the Prize Court are determined by the Court.

Article 21.—Procurators and petitioners may appeal to the Higher Prize Court against the decisions of the Prize Court.

Article 22.—The time allowed for appeal is twenty days from the day following the announcement of decision, or the transmission of written decision.

Article 23.—The appeal shall be made in writing at the Prize Court.

The written appeal shall contain the principal points of appeal, and a detailed account of the ground on which the same is based.

The written appeal of a petitioner is required to be signed by a Japanese advocate.

Article 24.—The written appeal of a Procurator shall be shown to the petitioner concerned by means of a copy prepared by the Prize Court, and that of a petitioner shall be shown to the Procurator concerned, and a written reply shall be required, within ten days. The written reply of a petitioner is required to be signed by a Japanese advocate.

Article 25.—At the expiration of the period allowed for the reply the Prize Court shall forward the documents concerning the appeal to the Higher Prize Court.

In case the Higher Prize Court deem it necessary to make a further examination of facts or proofs, the documents mentioned in the preceding clause shall be returned to the Prize Court ordering such examination.

The Prize Court shall order the Councillor in charge to make such examination, and the documents related thereto shall be shown to the Procurator and petitioner before they are forwarded to the Higher Prize Court.

Article 26.—The examination made by the Higher Prize Court shall be based upon documents.

Article 27.—Rules concerning the proceedings of the Higher Prize Court shall be determined by that Court.

Article 28.—Captures adjudged as prizes form an acquisition of State.

Article 29.—Captured vessels or goods shall be kept, until the final decision, in custody of the Naval authorities, determined by the Minister for the Navy.

Article 30.—The enforcement of a decision shall be made by the Procurator of the Prize Court.

The Procurator of the Prize Court may, in enforcing a decision, ask the assistance of the Naval authorities, or employ police officials.

Article 31.—The provisions of the present chapter shall be applied to cases where captured vessels are not brought in owing to special circumstances, in so far as they are enforceable.

Additional Rule.

Article 32.—The present Ordinance shall be put in force from the date of promulgation.

Notification abolishing Toll.

WHEREAS by section 3 of Ordinance No. 12 of 1885 it is amongst other things enacted that it shall be lawful for the Governor, acting with the advice of the Executive Council, by Resolution, to be notified in the *Government Gazette*, to abolish any existing tolls or any tolls which may hereafter be legally established, anything in "The Tolls Ordinance, 1867," to the contrary notwithstanding:

It is hereby notified for general information that the Lieut.-Governor, with the advice of the Executive Council, by virtue of the powers conferred by the said Ordinance, has, by Resolution of the 29th day of December, 1894, abolished the toll established at Moratota, on the Badulla-Nuwara Eliya road, as from and after the 1st day of January, 1895.

ABSTRACT OF SEASON REPORTS FOR THE MONTH ENDED DECEMBER 31, 1894.
NORTH-WESTERN PROVINCE.**PUTTALAM DISTRICT.**

Paddy sown for maha crop fair and good.

Dry grain : kurakkan earing ; crop good.

Rainfall during quarter sufficient and favourable for agriculture. Mahauswewa and almost all other tanks full.

NORTH-CENTRAL PROVINCE.**ANURADHAPURA DISTRICT.**

There has been moderate rainfall during the month. Rainfall registered at Anuradhapura has been 6.58 inches.

Paddy fields under tanks which have been partially filled during the month are being cultivated, and the prospects for the maha are better than they were in the early part of the month. More rain, however, is urgently required, and the time during which it can be expected is drawing to a close.

Maha tavalu are about to blossom ; a large extent has been sown.

Kurakkan is maturing in the districts in which chenas have been allowed. Owing to limited rainfall the maha cultivation has been confined to a portion only of the Province.

THE following Quarantine Regulations published in the *Gazette* of the 22nd June, 1894, are re-published for general information.

REGULATIONS made by the Governor, with the advice of the Executive Council, in pursuance of the provisions in that behalf contained in the 10th section of the Ordinance No. 8 of 1866, intituled "An Ordinance to prevent the spread of Contagious Diseases in this Island."

QUARANTINE REGULATIONS.

1. The regulations made under the said Ordinance No. 8 of 1866, and published under dates respectively May 6, 1873, August 3, 1876, September 9, 1876, January 26, 1877, and February 10, 1877, are hereby severally repealed, except so far as the same or any of them repeal any previous regulations.
2. The master or other person in charge of any vessel entering or about to enter any part of this Island, in which vessel any case of cholera, yellow fever, Asiatic plague, smallpox, or other disease dangerous to the general health may have occurred within a period of ten days previous to the date of the arrival of such vessel, shall notify this fact by hoisting a signal, which signal shall be in the day time a yellow flag at the fore, and in the night time two lighted lanterns, one over the other, at the same mast-head ; and such master or other person, as aforesaid, shall not take up anchoring ground within the said port without having obtained the previous sanction of the Master Attendant or other officer in charge of the port, nor without such leave shall he hold any communication with the shore or with any shipping within the said port.
3. It shall be the duty of the health officer, or other officer nominated by the principal civil medical officer of the port, to proceed without delay on board any vessel entering or about to enter any of the ports aforesaid, in which vessel any case of cholera, yellow fever, Asiatic plague, smallpox, or other disease dangerous to the general health shall have occurred within ten days previous to the date of the arrival of such vessel as aforesaid, and such health officer or other medical officer as aforesaid shall inspect the crew and passengers of such vessel, and make careful inquiry as to the nature of the diseases then existing on board thereof, and make a report thereon to the Master Attendant or other officer in charge of the said port.
4. Whenever cholera, yellow fever, Asiatic plague, smallpox, or other disease dangerous to the general health shall be actually prevailing amongst any of the crew or passengers of any vessel as aforesaid, it shall be the duty of the principal civil medical officer of the port to report the state of the facts to the Master Attendant or other officer in charge of the port. Thereupon the Master Attendant or other officer in charge of the port shall, if so required by the said medical officer, place the vessel in quarantine, and shall require the master or other person in charge of such vessel as aforesaid to take the said vessel out to sea for a period of ten days, or to anchor at any place to be appointed for that purpose for a period of ten days, or until the said medical officer of the port reports that she may be released.

5. Every vessel entering or about to enter any port of this Island shall, if cholera, yellow fever, Asiatic plague, or smallpox shall be at the time of her leaving the last port from which she shall have put out, or shall have been during the ten days next preceding her departure therefrom, prevalent in or about such last-mentioned port, whether such port shall be within or without this Island, and no such disease shall have appeared on board, be subjected to a quarantine for such period not exceeding ten days as the principal civil medical officer of the port of arrival shall deem advisable. The master or other person in charge of such vessel shall notify the fact of his having last sailed from an infected port by hoisting signals as in regulation 1 of the regulations of February 2, 1888, provided with reference to vessels on board of which disease has appeared; and the rules in the same regulation contained as to anchoring or holding communication with the shore shall apply to the case of vessels coming under this regulation.

6. It shall be lawful for the principal civil medical officer of the port, into which any vessel subject to quarantine shall enter, to allow the passengers to land before the expiration of the quarantine, and to require such passengers to perform their quarantine on shore in such place as such officer shall determine.

7. All persons on board any vessel in quarantine are hereby prohibited from communicating with the shore beyond the limits of any place which may be set apart for performing quarantine on shore, or with any vessel in the roadstead or port or vicinity thereof, except with the permission of the principal civil medical officer of the port; and all persons are hereby prohibited from going on board any vessel in quarantine, except with such permission as aforesaid. And all persons required to perform quarantine in any place on shore are hereby prohibited during such quarantine from leaving such place or communicating with any person beyond or outside such place without such permission aforesaid. And all persons not in quarantine are hereby prohibited from communicating with any persons in quarantine on shore, except with such permission as aforesaid.

8. It shall be lawful for every officer, duly authorized by the Government in that behalf, to appoint a sufficient number of subordinates for the purpose of enforcing any of these rules, in respect of any vessel liable to quarantine, at the expense of the owners of such vessel; and the master or other person in charge of such vessel shall pay the subordinates so appointed and defray all expenses incurred in pursuance of this rule. It shall be the duty of the officer in charge of the custom-house to refuse port clearance to such vessel until all such demands be discharged.

9. It shall be lawful for every officer duly appointed as aforesaid, with the sanction of Government, to appoint as many places for performing quarantine on shore as may be required, and to provide accommodation at such places for passengers on board any vessel liable to quarantine, at certain fixed fees to be determined from time to time by the Government, which fees shall be payable by the master or other person in charge of such vessel. No person shall be permitted to leave the places so appointed within ten days from the date of the last case of the disease for which quarantine was enforced, unless with the previous sanction of the said officer duly authorized as aforesaid.

10. Any of the duties and powers vested by these regulations in the principal civil medical officer of the port may be performed and exercised by any person duly authorized by the Governor in that behalf.

11. Disobedience to any of the above regulations will subject the offender, and all persons aiding and abetting him, to a prosecution under section 11 of Ordinance No. 8 of 1866.
