I, hereby give notice, under Sub-section (1) of Section 7 of the Land Acquisition Act, as amended by the Land Acquisition (Amendment) Act, No. 28 of 1964, that the Government intends to acquire the following land for the construction of water tank and quarters under the Anuradapura North water supply project.

Description of the land or servitude to be acquired:
