#### Order under Section 4, Sub-section (1), of "The Waste Lands Ordinances of 1897, 1899, 1900, and 1903."

In the matter of the lands commonly called or known as Eratnadeniyemukalana, Wewekeleyaya, and Ambalanowita, in the village of Labugama (part of), in the Meda pattu of the Hewagam korale of the Colombo District, in the Western Province, and of "The Waste Lands Ordinances of 1897, 1899, 1900, and 1903."

WHEREAS in pursuance of section 1 of the said Ordinances it was duly declared and notified on the 20th day of January, 1922, that if no claim to the lands commonly called or known as Eratnadeniyemukalana, Wewskeleyaya, and Ambalanowita, situate in the village of Labugama (part of), in the Meda pattu of the Hewagam korale of the Colombo District, in the Western Province, containing in extent 28 acres and 16 perches, and shown as lots 39A and 47 in block surv v preliminary plan 98 and in the annexed diagram, was made to Maxwell MacLagan Wedderburn, Special Officer apport to inder section 28 of the said Ordinances, within the period of three months from the date specified in the said notice, such lands would be declared the property of the Crown, and dealt with on account of the Crown (vide Notice No. 8,022):
