Order under Section 4, Sub-section (1), of "The Waste Lands Ordinances of 1897, 1899, 1900, and 1903," declaring Land to be Crown Property.

In the matter of the lands commonly called or known as Kapugekotuwa *alias* Aswedduma *alias* Nekatgederahena (reservation for water-course), &c., situate in the village of Nalanda, in the Wagapanaha Udasiya pattu of the Matale north division of the Matale District, in the Central Province, and of "The Waste Lands Ordinances of 1897, 1899, 1900, and 1903."

WHEREAS in pursuance of section 1 of the said Ordinances it was duly notified on the 29th day of September, 1922, that if no claim to the lands commonly called or known as Kapugekotuwa *alias*.
