FINAL ORDERS.

Hambantota S. O. No. 1,735.

Order under Section 4, Sub-section (1), of "The Waste Lands Ordinances of 1897, 1899, 1900, and 1903."

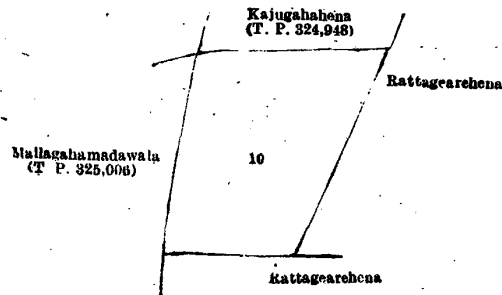
In the matter of the land commonly called or known as Rattagearehena, situate in the village of Bedigama, in the West Giruwa pattu of the Hambantota District, in the Southern Province, and of "The Waste Lands Ordinances of 1897, 1899, 1900, and 1903."

WHEREAS in pursuance of section 1 of the said Ordinances it was duly declared and notified on the 12th day of October, 1917, that if no claim to the land commonly called or known as Rattagearehena, situate in the village of Bedigama, in the West Giruwa pattu of the Hambantota District, in the Southern Province, containing in extent 7 acres and 21 perches, and shown as lot 10 in block survey preliminary plan 261 and in the annexed diagram, was made to Thomas Graham Willett, Special Officer appointed under section 28 of the said Ordinances, within the period of three months from the date specified in the said notice, such land would be declared the property of the Crown, and dealt with on account of the Crown (*vide* Notice No. 6,605) :

And whereas Lokugamage Don Andris Appuhamy made claim thereto, and John Murray Davies, Howard Orme Fox, and Frederick Lewis, Special Officers appointed under section 28 of the said Ordinances, made due inquiry into such claim; and whereas the said claimant and the aforesaid Howard Orme Fox came to an agreement in writing dated the 17th day of December, 1919, concerning the said land, under section 4, sub-section (1), of the said Ordinances, whereby it was agreed that the said claimant should be declared the purchaser of the said land, upon payment on or before the 17th day of March, 1920, to the Treasury Officer at Tangalla, or to the Settlement Officer, of a sum of Rupees One hundred and Twelve only (Rs. 112), as the purchase amount of the said land; and whereas the said amount has been duly paid by the said claimant, he is hereby, in pursuance of the agreement aforementioned, declared to be the purchaser of the said land, as more fully described herein below.

Description of the Land referred to.

The land commonly called or known as Rattagearehena, situate in the village of Bedigama, in the West Giruwa pattu of the Hambantota District, in the Southern Province, containing in extent 7 acres and 21 perches, shown as lot 10, in block survey preliminary plan 261 and in the annexed diagram; and bounded as follows: on the north by Kajugahahena (T. P. 324,948); on the east by Rattagearehena sold under the Waste Lands Ordinances to Punchihewage Mathes de Silva and another; on the south by Rattagearehena sold under the Waste Lands Ordinances to Gangodage Don Dines and others; on the west by Mailagahamadawala (T. P. 325,006).
