#### FINAL ORDERS.

#### Kurunegala S. O. No. 3,579.

#### Order under Section 4, Sub-section (1), of "The Waste Lands Ordinances of 1897, 1899, 1900, and 1903."

In the matter of the land commonly called or known as Palugahawetiyahena, situate in the village of Walpaluwa, in Giratalane korale of the Dewamedi hatpattu of the Kurunegala District, in the North-Western Province, and of "The Waste Lands Ordinances of 1897, 1899, 1900, and 1903."

WHEREAS in pursuance of section 1 of the said Ordinances it was duly declared and notified on 1st day of October, 1920, that if no claim to the land commonly called or known as Palugahawetiyahena, situate in the village of Walpaluwa, in the Giratalane korale of the Dewamedi hatpattu of the Kurunegala District, in the North-Western Province, containing in extent 3 acres 1 rood and 37 perches, and shown as lot 1c1 in block survey preliminary plan 1,736, was made to Harry Chambers Toller, Esq., Special Officer appointed under section 28 of the said Ordinances, within the period of three months from the date specified in the said notice, such land would be declared the property of the Crown, and dealt with on account of the Crown (vide Notice No. 7,617):

And whereas (1) Herat Mudiyanselage Banda, (2) Muna Kana Awanna Adam Lebbe made claim thereto, and Norman Albert Hampton, Esq., Special Officer appointed under section 28 of the said Ordinances, made due inquiry into such claims; and whereas the said 1st and 2nd claimants and Norman Albert Hampton, Esq., the aforesaid Special Officer, came to an agreement in writing dated the 9th day of March, 1922, concerning the said land, under section 4, sub-section (1), of the said Ordinances, whereby it was agreed that the said 1st and 2nd claimants should be declared the purchasers of 3 acres 1 rood and 33 perches more or less of lot 1c of the notice and of the block survey preliminary plan 1,736, now shown as lot 1cl on the same plan, upon payment to the Government Agent at Kurunegala, or to the Settlement Officer, on or before the 9th day of June, 1922, later extended to the 24th day of July, 1922, of a sum of Rupees Fifty-six (Rs. 56) only, as the purchase amount of the said land; and whereas the said amount has been paid within the extended time, the said (1) Herat Mudiyanselage Banda and (2) Muna Kana Awanna Adam Lebbe, are hereby, in pursuance of the agreement aforementioned, declared to be the purchasers of the said land, as more fully described herein below, and as described in the survey and description thereof authenticated by Arthur Joseph Wickwar, Esq., Surveyor-General, bearing date the 25th day of September, 1924, No. 362,982/F.
