THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, John Anthony Emmanuel Amarathunga, Minister of Lands, hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, that the servitude over the land, described in the following paragraph 1 is needed for a public purpose and will be acquired under the provisions of that Act. It describes in paragraph 2 from which land that the servitude will be acquired.

1. *Description of the Servitude.* - Acquisition of servitude over the land, for laying of Distribution Lines, from Pallegattuwana High Lift Pump House up to Gettuwana of Greater Kurunegala Water Supply and Sanitation project:.

2. *Description of the Land.* - The lands mentioned as following names and extent shown and described in the Advance Tracing No. KU/KRN/2015/282 dated 20.08.2015, prepared by the Surveyor General, situated at the village of Gettuwana (Ward No. 7 within the Municipal Council Limit, Kurunegala) in the Divisional Secretary's Division of Kurunegala in Kurunegala District, North Western Province and bounded as follows:
