FINAL ORDERS.

Order under Section 4, Sub-section (1), of "The Waste Lands Ordinances of 1897, 1899, 1900, and 1903."

In the matter of the land commonly called or known as Helandakadegawahena, situate in the village of Pelwadiya, in the Meda pattu of the Nawadun korale of the Ratnapura District, in the Province of Sabaragamuwa, and of "The Waste Lands Ordinances of 1897, 1899, 1900, and 1903."
