DRAFT ORDINANCES.

MINUTE.

The following Draft of a proposed Ordinance is published for general information :—

An Ordinance relating to the publication of intended sales or other alienations of Immovable Property affected by the "Thesavalamai" of the Northern Province of Ceylon.

Preamble.

WHEREAS it is expedient to repeal the provision for the publication of sales and other alienations of immovable property situated in those parts of the Northern Province to which the *Thesavalamai* applies: Be it therefore enacted by the Governor of Ceylon, by and with the advice and consent of the Legislative Council thereof, as follows :

Repeal of so much of the *Thésavañamai* as requires publication and schedule of sales of immovable property, and, repeal of Ordinance No. 1 of 1842.
Proviso.

1 From and after the date on which this Ordinance comes into operation, so much of the *Thésavañamai* prevailing in certain parts of the Northern Province as requires publication and schedule of intended sales or other alienations of immovable property, and the whole of the Ordinance No. 1 of 1842, entitled "To make certain Regulations respecting the granting of Schedules on execution of deeds affecting land in the Northern Province," shall be repealed.

Provided that such repeal shall not affect any right, privilege, obligation, or liability acquired, accrued, or incurred, nor anything duly done or suffered under the said Ordinance, nor any penalty, forfeiture, or punishment incurred in respect of any omission, or neglect, or delay, or illegal demand under the said Ordinance, nor any legal proceedings or remedy in respect of any such right, liability, obligation, penalty, forfeiture, or punishment as aforesaid.
