THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, John Anthony Emmanuel Amarathunga, Minister of Lands, hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, that the lands described below are needed for a public purpose and will be acquired under the provisions of that Act.

The allotments of land depicted in Advance Tracing No. Maha/HRS/2016/120 and dated 13th May, 2016, prepared by the Surveyor General situated in the Village of Kumburegedara, in the Minor Division of Kulugammuna Siyapathuwa in Divisional Secretary's Division of Harispathuwa in Kandy District, Central Province and bounded as follows:

01. Lot 'A' – Hallemulle Waththa and Hallemulle Land – Extent: 0.0076 Hectare

Declaration under Section 5

I, John Anthony Emmanuel Amaratunga, Minister of Lands hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for the Knuckles Conservation area and will be acquired under the provisions of that Act.
