THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, John Anthony Emmanuel Amarathunga, Minister of Lands, hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below are needed for a public purpose and will be acquired under the provisions of that Act.

The allotments of below name lands depicted in Advance Tracing No. Maha/MHN/2016/74 and dated 16/06/2016, prepared by the Surveyor General, situated in village of Dodanwala in the Minor Division of Gangawatakorale in Divisional Secretary's Division of Kandy Four Gravets and Gangawatakorale in the Kandy District in the Central Province bounded as follows:

01. Lot 'A' – Halawewatta *alias* Hallemulle Watta – Extent: 0.0027 Hectare
