THE LAND ACQUISITION ACT, (CHAPTER 460)

Declaration under Section 7

I, hereby notify under Sub-section (7) of the Land Acquisition Act as amended by the land Acquisition (Amendment) Act, No. 28 of 1964 that the Government intends to acquire the following lands which are required for public purpose.

Description of the land or servitude to be acquired:

Allotments of the land situated at Sapugahawatta Village in the Grama Niladhari's Division, Sapugahawatta of the Divisional Secretariat, Dodangoda in Kalutara District in Western Province, depicted from Lot No. 01 to Lot No. 02 of P.P.Ka.4527 & dated 2016.10.25 made by the Surveyor General, containing in extent about 0.0194 Hectare and boundaries of the land given below:

1. Lot No.01—Name of the Land: Katarallagahawatta; Land Use: Gardan; Land ownership: State; First Claimant: U.K.D. Jinasena, Sapugahawtta, Dodangoda; Extent: about 0.0033Hectare.
