THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, John Anthony Emmanuel Amarathunga, Minister of Lands do hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of the Land Acquisition Act.

An allotment of land called Watta depicted in the Advance Tracing No. PO/HKG/2012/346 dated 20.09.2016, prepared by the Surveyor General in the Village of Minneriya in the Sinhala pattuwa Minor Division in the Hingurakgoda Divisional Secretary's Division in the District of Polonnaruwa in the North Central Province and containing in extent 0.0637 Hectare and bounded as follows:

01. Lot A – Watta – Extent: 0.0637 Hectare

North: Remaining portion of the land claimed by B. L. Peter; East: Minneriya Rathmale Reserve and Lot B; South: Land wherein Minneriya Water Plant is located; West: Remaining portion of the land claimed by B. L. Peter.

THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, John Anthony Emmanuel Amarathunga, Minister of Lands, hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition

Act, that the servitude over the land, described in the following Chapter 1 is needed for a public purpose and will be acquired under the provisions of that Act. It describes in Chapter 2 from which land that the servitude will be acquired.

1. **Describe of the Servitude.**– Acquisition of Servitude over the land, for the Access Road to Kurunegala Water Treatment Plant of Greater Kurunegala Water Supply & Sanitation Project.

2. **Describe of the Land.**– The allotment of land called "Paramount Watta" in total extent of about 0.0134 Hectare, described in the Advance Tracing No. KU/KRN/2015/281 dated on 22.06.2015, prepared by the Surveyor General, situated at the Village of Kurunegala in Kurunegala Town - North - East Grama Niladhari Division, No. 834 in the Divisional Secretary's Division of Kurunegala in Kurunegala District, North Western Province and bounded as follows:
