PASSED ORDINANCES.

O 34/1927

Ordinance enacted by the Governor of Ceylon, with the advice and consent of the Legislative Council thereof.

No. 1 of 1927.

An Ordinance to amend the Dried Meat Ordinance, 1908.

HUGH CLIFFORD.

BE it enacted by the Governor of Ceylon, by and with the advice and consent of the Legislative Council thereof, as follows :

- Short title. 1 This Ordinance may be cited as the Dried Meat Ordinance, No. 1 of 1927.
- Amendment of section 3 (1) of the principal Ordinance. 2 Section 3 (1) of the principal Ordinance is hereby amended by the addition of the following words at the end thereof, viz. :
 “ except in accordance with any conditions which may be set forth in the said Proclamation, which said conditions may include the payment of money to the Government for the privilege of removing dried meat.”
- Amendment of section 4 of the principal Ordinance. 3 Section 4 of the principal Ordinance is hereby amended by the addition of the following words at the end thereof, viz. :
 “ in contravention of a Proclamation issued under the preceding section.”
- Amendment of section 5 of the principal Ordinance. 4 Section 5 of the principal Ordinance is hereby amended by the substitution of the words “ in contravention of this Ordinance or any Proclamation issued thereunder ” for the words “ from any proclaimed area ” in line 2 thereof.
- Amendment of section 9 of the principal Ordinance. 5 Section 9 of the principal Ordinance is hereby amended as follows :
 (a) By the insertion of the following words immediately after the word “ expedient ” in line 3 of the first paragraph thereof :
 “ except in accordance with any conditions which may be set forth in the said Proclamation, which said conditions may include the imposition of fees for the inspection of meat proposed to be exported ” ;
 (b) By the insertion of the words “ in contravention of the said Proclamation ” after the word “ meat ” in line 3 of the second paragraph thereof ; and
 (c) By the insertion of the word “ unlawfully ” after the word “ person ” in line 3 of the second paragraph thereof.
- Proclamations to be laid on table of Legislative Council. 6 The following shall be added to the principal Ordinance as section 12 :
 12 All Proclamations issued under this Ordinance shall, as soon as conveniently may be, be laid on the table of the Legislative Council, and may at any of the next three meetings of the Council be disallowed by resolution of the Council, and if so disallowed shall be annulled, but without prejudice to anything already done thereunder, and if not so disallowed shall be deemed to be valid.

Ordinance enacted by the Governor of Ceylon, with the advice and consent of the Legislative Council thereof.

No. 2 of 1927.

An Ordinance to amend the Nuwara Eliya Board of Improvement Ordinance, 1896.

HUGH CLIFFORD.

BE it enacted by the Governor of Ceylon, by and with the advice and consent of the Legislative Council thereof, as follows :

1 This Ordinance may be cited as the Nuwara Eliya Board of Improvement Ordinance, No. 2 of 1927. Short title.

2 In section 15 of the principal Ordinance (which empowers the Nuwara Eliya Board of Improvement to make and assess rates) the words " eight per centum " shall be substituted for the words " six per centum " in line ten. Amendment of section 15 of the principal Ordinance.

3 (1) In section 17 of the principal Ordinance the words—
 " Provided that the Chairman of the Board of Improvement shall assess, collect, and recover the assessment rate payable under this Ordinance, and shall pay the rate, into the fund, and may, for the purpose of assessing, collecting, and recovering the rate, by himself or the agents and servants of the Board, exercise the powers and perform the duties which, by the Police Ordinance, 1865, as amended by any subsequent enactment, are conferred or imposed on the Government Agent for the assessment, collection, or recovery of the police tax, but so that no property shall be seized for non-payment of the rate unless it is found within the limits of the town of Nuwara Eliya." Amendment of principal Ordinance as to collector of assessment and water rate.

shall be substituted for the words—

"The Assistant Government Agent of Nuwara Eliya shall collect and recover the assessment rate payable under this Ordinance, and shall pay such rate into the fund."

(2) In section 38 (2) of the principal Ordinance the words—

" and shall be assessed, collected, recovered, and paid into the fund by the Chairman of the Board in the same manner as the assessment rate levied under this Ordinance,"

shall be substituted for the words—

" and shall be collected, recovered, and paid over to the Board of Improvement by the Assistant Government Agent in the same manner as the assessment rate levied under this Ordinance."
