Order under Section 4, Sub-section (1), of "The Waste Lands Ordinances of 1897, 1899, 1900, and 1903."

In the matter of the lands commonly called or known as Yahalahenedeniya, situate in the village of Liniyawa of the Maha pattu south, in the Pasdun korale east of the Kalutara District, in the Western Province, and of "The Waste Lands Ordinances of 1897, 1899, 1900, and 1903."
