Order under Section 4, Sub-section (1), of "The Waste Lands Ordinances of 1897, 1899, 1900, and 1903," declaring Land to be Crown Property

In the matter of the lands commonly called or known as Humbuluweowita, and Humbuluweowita (reservation for cart track), situate in the village of Liniyawa of the Maha pattu south. In the Pasdun korale east of the Kalutara District, in the Western Province, and of "The Waste Lands Ordinances of 1897, 1899, 1900, and 1903"

WHEREAS in pursuance of section 1 of the said Ordinances, it was duly notified on the 16th day of January, 1925, that if no claim to the lands commonly called or known as Humbuluweowita, and Humbuluweowita (reservation for cart track), situate in the village of Liniyawa of the Maha pattu south, of the Pasdun korale east of the Kalutara District, in the Western Province, containing in extent 1 acre and 36 perches, and shown as lots 103 and 103B in block survey preliminary plan No 106, was made to Walter Terence Stace, Esq.
