Order under Section 4, Sub-section (1), of "The Waste Lands Ordinances of 1897, 1899, 1900, and 1903."

In the matter of the lands commonly called or known as Kosbittaragahahena, Ambagaswetehehena *alias* Gothalehena, &c., situate in the village of Koswatta, in the Udugoda Udasiya pattu of Matale North division of the Matale District, in the Central Province, and of "The Waste Lands Ordinances of 1897, 1899, 1900, and 1903."
