Order under Section 4, Sub-section (1), of "The Waste Lands Ordinances of 1897, 1899, 1900, and 1903."

In the matter of the land commonly called or known as Kosgahamulahena, situate in the village of Walmoruwa, in the Udugoda Udasiya pattu of the Matale North division of the Matale District, in the Central Province, and of "The Waste Lands Ordinances of 1897, 1899, 1900, and 1903."

WHEREAS in pursuance of section 1 of the said Ordinances it was duly declared and notified on the 27th day of May, 1921, that if no claim to the land commonly called or known as Kosgahamulahena, situate in the village of Walmoruwa, in the Udugoda Udasiya pattu of the Matale North division of the Matale District, in the Central Province, containing in extent 2 acres 1 rood and 11 perches, and shown as lot 382 in block survey preliminary plan 31, was made to Mungo Tennent Archibald, Esq., Special Officer appointed under section 28 of the said Ordinances, within the period of three months from the date specified in the said notice, such land would be declared the property of the Crown, and dealt with on account of the Crown (*vide* Notice No. 7,876):
