I, hereby give notice, under Sub-section (1) of Section 7 of the Land Acquisition Act, as amended by the Land Acquisition (Amendment) Act, No. 28 of 1964, that the Government intends to acquire the following lands for the widening and development of Norris Canal in Maradana under the Metro Colombo Urban Development Project:
