Order under Section 4, Sub-section (1), of "The Waste Lands Ordinances of 1897, 1899, 1900, and 1903," declaring Land to be Crown Property.

In the matter of the lands commonly called or known as Kongahadalupota and Katuwalalanduyaya, situate in the village of Nagallegama, in the Katuwanna korale of the Wanni hatpattu of the Kurunegala District, in the North-Western Province, and of "The Waste Lands Ordinances of 1897, 1899, 1900, and 1903."
