A PROCLAMATION.

H. J. STANLEY.

WHEREAS by a Proclamation dated February 28, 1900, His Excellency the Governor, with the advice of the Executive Council, divided the Kandyan Provinces enumerated in Schedule B to the Ordinance No. 3 of 1870 into districts and the districts into divisions as set forth in the schedule to the said Proclamation for the purposes of the registration of Kandyan Marriages :

And whereas it is expedient to amend and alter and re-define the descriptions of the four Kandyan Marriage Registration divisions in the Batticaloa District of the Eastern Province :

Now Know Ye that We, the said Governor, with the advice of the Executive Council, in exercise of the powers vested in Us by section 5 of the said Ordinance, do by this Our Proclamation, with effect from January 1, 1929, amend, alter, and re-define the descriptions of the said four divisions of Batticaloa District more fully specified in the first column of the annexed schedule in the manner specified in the second column thereof.

SCHEDULE.

Eastern Province—Batticaloa District.

I.

3.—*Panawa Pattu Division.*

Boundaries: North by Akkarai pattu; south by Kumbukkan-aar; east by the sea; west by the Province of Uva.

1.—*Akkarai Pattu Division.*

Boundaries: North by Nintavur pattu; south by Panawa pattu; east by the sea; west by the Province of Uva.

2.—*Nadukadu Pattu Division.*

Boundaries: North by Porativu pattu; south by Akkarai pattu vanam; east by the Chammanturai and Akkarai pattus; west by the Province of Uva.

4.—*Bintenna Pattu Division.*

Boundaries: North by Rukam pattu; south by the Province of Uva; east by the Nadukadu and Porativu pattus and Crown jungle; west by the Central Province and Province of Uva.

II.

No. 1.—*Panawa Pattu.*

Boundaries: North, Akkarai pattu and Wewgam pattu; east, the sea; south, Kumbukkan-aar; west, the limits of Province of Uva.

No. 2.—*Wewgam Pattu.*

Boundaries: North, from the point where the Kuda-oya falls into the Magulawattawan-oya, a straight line drawn east south-east to the top of Balagala, from thence a straight line to the top of the northern spur of Rakshagala, and thence a straight line to the highest point of the rocky ridge running north and south about a mile to the north-west of Kachchikodiya Gangoda; east, from this point a line running south south-east along the ridge and from the southern end of the ridge to the north-western end of Kachchikodiya tank bund, the said bund to its south-eastern extremity, thence a straight line running roughly south south-east to the junction of the cart road from Yothiyankaddu with the Diwulana-Wellaweli road, from this point a straight line running southwards to meet the northern branch of the Kalugal-aar the said branch of Kalugal-aar westwards and south-westwards to the point where it meets the other branch, from this point the southern branch of the Kalugal-aar running eastwards and south-eastwards as far as the eastern boundary of the Gonagolla tract of paddy fields, thence the eastern boundary of the said tract of paddy fields to its south-eastern corner, thence a straight line drawn southwards to the junction of the Uhana-ela with the Andella-oya, thence a straight line drawn south-eastwards to the top of the rocky hill, situated about $\frac{3}{4}$ of a mile to the north-west of Veeragoda tank, thence a straight line drawn south-eastward to the point at which the Etinnawetichchakandura falls into Veeragoda tank, thence the Etinnawetichchakandura south-westwards up to the point where it crosses the cart track from Heen-Veeradiya to Karangawa, from this point a straight line drawn to the highest point of the rocky hill lying about a mile to the west, from the top of this hill a straight line drawn south-westwards to the north-western point of Kondavaddavan tank, thence the contour of the said tank south-westwards, south-eastwards, westwards, and southwards to the point at which the Bakiniattawa-ela falls into the said tank from this point a straight line drawn to the highest point of the rocky hill lying about 2 miles to the south, from this point a straight line drawn south south-eastwards to the Kanankadu Irrigation Bungalow, from the said bungalow a straight line drawn eastwards to the large rock about ten chains to the east of the Muwangalawewa bund thence a straight line drawn south-eastwards to the summit of Ehenagala-ela from the said summit a straight line drawn south-eastwards to the top of the rocky hill lying 3 miles to the north-east of Sagamam tank and about $\frac{1}{2}$ of a mile north of the Pannala-oya, thence a line drawn south to the Pannala-oya; south, the Pannala-oya, south-westwards to the point at which it crosses a line drawn due northwards from the northern spur of the hill line 2 miles to the west of Varanmiyadi tank, thence the said line and the ridge of the said hill running southwards up to its highest point, from this point a straight line drawn south-westwards to Kondaruhela Trigonometrical Station, from this Trigonometrical Station a line drawn due west till it meets the Province boundary; west, the boundary between the Eastern Province and Province of Uva up to the point where this boundary cuts the Magulawattawan-oya, the Magulawattawan-oya up to the point where the Kuda-oya falls into it.

No. 3.—*Bintenna Pattu.*

Boundaries: North, the boundary of Eravur pattu; east, the boundary of Manmunai North and Wewgam pattu as far as the Province of Uva boundary; south, Province of Uva boundary; west, Province of Uva boundary.

"THE MOTOR CAR ORDINANCE, 1927."

J 92/28

REGULATIONS made by the Governor in Council, under section 74 of the Motor Car Ordinance, 1927.

1. Forms 11, 12, and 13 in the Third Schedule to the Motor Car Ordinance, 1927, are hereby amended by the deletion of the words "and also a copy of the said certificate", where those words occur in each of the said Forms.
2. Form 18 in the said Schedule is hereby amended by the deletion of the words "per car" in the space provided for the revenue stamp.
3. Form 24 in the said Schedule is hereby amended by the deletion of the words "for each class of car" in the space provided for the revenue stamp.

"THE MOTOR CAR ORDINANCE, 1927."

REGULATION made by the Governor in Council, under section 71 of the Motor Car Ordinance, 1927.

The Fourth Schedule to the Motor Car Ordinance, 1927, is hereby amended as follows :—

(1) In the fifth and sixth lines of provision 1, the words "and may on special occasions allow departure from such routes" are rescinded.

(2) The following provision is inserted immediately after provision 1 :—

Religious
festivals and
other special
occasions.

1A (1) Notwithstanding anything contained in provision 1, the licensee of an omnibus who desires to run the omnibus to any religious festival or for any other special occasion on routes other than the routes for which the omnibus is licensed shall apply to the officer in charge of the nearest police station for a permit to do so.

(2) Any such permit shall be issued free of charge, but the issue thereof implies no guarantee that the routes for which it is issued will be in good order, and does not affect the powers of the Director of Public Works or any other authority to close any road.

(3) Every omnibus shall, while using any such permitted routes, carry a board marked "Special", fixed above each of the destination indicators referred to in provision 18, and the letters and background of any such board shall be of the same nature and colours and dimensions as those of the said destination indicators.

(4) Every such permit shall be carried on the omnibus while it is using the routes for which the permit was issued, and shall be produced on demand for inspection by a police officer or headman.

(3) In the third line of provision 6 (2), the word "unless" is substituted for the word "not".

(4) Provision 8 is rescinded.

(5) The following provision is inserted immediately after provision 11 :—

Centre seats.

11A. Where the seats of an omnibus are placed lengthwise along the sides of the omnibus, any seats constructed on any portion of the intervening space between the seats placed lengthwise shall—

- (1) be constructed either as separate single seats, each of which shall face the front of the omnibus, or in sets of two single seats back to back ;
- (2) be placed so as to be equidistant on both sides from the sides of the omnibus ; and
- (3) be 15 inches in width, and have an unimpeded space on all sides of not less than 13 inches ; Provided that where any two such single seats face each other the unimpeded space between them shall be not less than 26 inches ;

and the distance between the entrance of the omnibus and the nearest point of the rearmost of such seats shall be not less than 27 inches.

(6) In provision 13, the word "eighteen" is substituted for the word "fifteen", and the words "Every omnibus shall be fitted with an emergency door to the satisfaction of the registrar, and such door, if situated on the right or off side of the omnibus, shall only be used for emergencies." are rescinded.

(7) In provision 14, the words "One person only may sit on the front seat with the driver, unless the seating accommodation on the driver's left is thirty inches or more in width, in which case two persons only may sit on the front seat with the driver, but such person or persons shall not occupy any portion of the driver's seat" are substituted for the words "One person only may sit on the front seat with the driver, and such person shall not occupy any portion of the driver's seat".

(8) Provision 16 is rescinded and the following provision is substituted therefor:—

16. No petrol, kerosine, or other inflammable liquid shall be carried in or on an omnibus except—

- (1) in quantities not exceeding ten gallons (exclusive of the contents of the fuel tank);
- (2) in the fuel tank and on the rear portion of the roof of the omnibus, or in some other position approved by the examiner; and
- (3) when not carried in the fuel tank, in tins properly constructed and screwed down so as to prevent leakage.

(9) In the first line of provision 18, the words "destination indicator" are substituted for the word "device".

(10) Provision 23 is rescinded.

"THE LOCAL GOVERNMENT ORDINANCE, No. 11 OF 1920."

WHEREAS by Notification dated May 21, 1927, information of the intention to constitute an Urban District Council for the area specified in the schedule to the said Notification was duly published in the *Government Gazette* of May 27, 1927, June 2, 1927, and July 1, 1927, and locally proclaimed as required by section 9 (2) of Ordinance No. 11 of 1920:

And whereas all representations made with respect to the constitution of the said Urban District Council having been duly considered, His Excellency the Governor did, by Order in Council dated March 24, 1928, and published in the *Government Gazette* of March 30, 1928, constitute an Urban District Council for the said area, the local administrative limits whereof are specified in the schedule hereto:

And whereas by order of His Excellency the Governor in Executive Council dated March 24, 1928, and published in the *Government Gazette* of March 30, 1928, it was ordered that the said Urban District Council shall consist of nine members, and that the said area be divided into six electoral divisions with the local limits defined in the said order:

And whereas the first election and nomination of members for the said Urban District Council have been completed in accordance with the provisions of the said Ordinance; and whereas it has become necessary to provide for the first meeting of the said Urban District Council:

It is hereby notified that His Excellency the Governor in Executive Council has, by virtue of the powers vested in him, under sections 20 and 255 of the said Ordinance, and of all other powers him enabling thereto, declared and ordered that the said Urban District Council shall be and is hereby constituted as from January 1, 1929, and that the first meeting of the said Council shall be held on January 8, 1929, at 10 A.M., at the Urban District Council Office.

SCHEDULE.

Dehiwala-Mount Lavinia.

North.—The Municipal limits of Colombo to a point 3 chains to the north-east of the Pamankade bridge on the Kirillapone canal. From this point a line drawn south-east parallel to the Colombo-Kesbewa Public Works Department road 3 chains distant from it to the north-east till it meets the Kalubowila-Kirillapone village boundary.

East.—The village boundary of Kalubowila to a point 3 chains to the east of the Gansabhawa road running from Kalubowila southwards to Nedimale; from this point a line running south parallel to the said Gansabhawa road to a point 3 chains to the north of the Dehiwala-Pepiliyana District Road Committee road. From this point a line drawn parallel to the said District Road Committee road eastwards to a point 3 chains to the east of the junction of the said road with the District Road Committee road running south to Attidiya; from this point a line running south and parallel to the said District Road Committee road and 3 chains to the east of it as far as the canal. The canal westwards as far as the point where the said canal turns northwards; from this point a line drawn due south until it meets the Ratmalana-Attidiya road. From this point the said Ratmalana-Attidiya road till it joins the Colombo-Galle road; thence the Colombo-Galle road southwards as far as the point at which the Kaldemulla Gansabhawa road branches off to the west.

South.—The village boundary between Ratmalana South and Kaldemulla and the village boundary between Ratmalana South and Angulana.

West.—The sea.

"THE BIRTHS AND DEATHS REGISTRATION ORDINANCE, 1895."

WHEREAS by Notification dated July 1, 1899, published in *Government Gazette* No. 5,629 of the same date, His Excellency the Governor, with the advice of the Executive Council, divided the Batticaloa District of the Eastern Province of the Island for the purpose of the registration of births and deaths into the 30 divisions specified in Part V. of the schedule to the said Notification :

And whereas divisions Nos. 1 and 2 were amended by Notification dated January 10, 1921, published in *Government Gazette* No. 7,153 of January 14, 1921 ; divisions Nos. 8 and 9 were amended by Notification dated March 8, 1915, published in *Government Gazette* No. 6,706 of March 26, 1915 ; division No. 12 was subdivided by Notification dated November 11, 1926, published in *Government Gazette* No. 7,556 of November 19, 1926 ; division No. 15 was subdivided by Notification dated December 3, 1917, published in *Government Gazette* No. 6,915 of December 14, 1917 ; division No. 18 was subdivided by Notification dated June 23, 1904, published in *Government Gazette* No. 5,992 of June 24, 1904, and by Notification dated June 28, 1906, published in *Government Gazette* No. 6,128 of June 29, 1906 ; division No. 19 was subdivided by Proclamation dated July 18, 1901, published in *Government Gazette* No. 5,793 of July 26, 1901, and by Notification dated November 12, 1913, published in *Government Gazette* No. 6,590 of November 14, 1913 ; and division No. 20 was subdivided by Notification dated March 5, 1904, published in *Government Gazette* No. 5,976 of March 11, 1904, and by Notification dated November 16, 1921, published in *Government Gazette* No. 7,227 of November 18, 1921 :

SCHEDULE.

Eastern Province—Batticaloa District.

I.

1.—*Batticaloa Town.*

Batticaloa Town consisting of (a) the Island of Puliantivu, bounded on all sides by the Batticaloa lake ; (b) a portion of the mainland, bounded on north, east, and south by the Batticaloa lake, west by the road from Maddikali to Urani and the lake.

2.—*Manmunai North.*

Boundaries : North, the sea and Batticaloa lake ; west, Batticaloa lake and Eravur pattu ; south, Batticaloa lake ; east, Batticaloa lake and the road from Maddikali to Urani.

4.—*Manmunai East, Northern Division.*

Boundaries : North by sea ; south by Kattankudiyirruppu and Crown jungle ; east by sea ; west by Batticaloa lake.

5.—*Manmunai East, North-Central Division.*

Boundaries : North by Manchantoduvai and Crown jungle ; south by Arrapattai and Crown jungle ; east by sea ; and west by Batticaloa lake.

6.—*Manmunai East, South Central Division.*

Boundaries : North by Kattankudiyirruppu and Crown jungle, south by Putukkudiyirruppu and Crown jungle, east by sea ; and west by Batticaloa lake.

7.—*Manmunai East, Southern Division.*

Boundaries : North by Talankuda and Crown jungle ; south by Kalutavalai and Crown jungle ; east by sea ; and west by Batticaloa lake.

II.

1.—*Batticaloa Town.*

Batticaloa Town consisting of (a) the Island of Puliantivu, bounded on all sides by the Batticaloa lake ; (b) a portion of the mainland, bounded on the north by the Batticaloa lake, east by the Batticaloa lake, south by the Batticaloa lake, and west by the road from Maddikali to Urani and the lake.

2.—*Manmunai North Division.*

Boundaries : North, the sea and Batticaloa lake ; east, Batticaloa lake and the road from Maddikali to Urani ; south, Batticaloa lake ; west, Batticaloa lake and Eravur pattu.

3.—*Manmunai East, Northern Division.*

Boundaries : North, the sea ; east, the sea ; south, minor road separating Manchantoduvai from Kattankudi as far as the deviation road and cart track leading from the deviation road 150 yards to the south of the 2nd milepost to the sea ; west, the Batticaloa lake.

4.—*Manmunai East, North-Central Division.*

Boundaries : North, minor road separating Manchantoduvai from Kattankudi as far as the deviation road and cart track leading from the deviation road 150 yards south of the 2nd milepost to the sea ; east, the sea ; south, Sanitary Board road No. 7 separating Arapattai from Kattankudi ; west, the Batticaloa lake.

5.—*Manmunai East, South Central Division.*

Boundaries : North, Sanitary Board road No. 7 separating Arapattai from Kattankudi ; east, the sea ; south, Putukkudiyirruppu village ; west, the Batticaloa lake.

6.—*Manmunai South, Eastern Division.*

Boundaries : North, a straight line running east to west from the Batticaloa lake through the 6¼ milepost on the Batticaloa-Kalmunai road as far as the sea ; east, the sea ; south, Kalutavalai village and the minor road leading to the Kalutavalai ferry ; west, the Batticaloa lake.

I.

24.—*Nadukadu Pattu West Division.*

Boundaries : North by Crown jungle ; south by Panawa pattu ; east by Crown jungle ; west by Province of Uva.

21.—*Akkarai Pattu West Division.*

Boundaries : North by Nadunkadu pattu ; south by Panawa pattu ; east by Crown jungle and west by Province of Uva.

23.—*Nadukadu Pattu East Division.*

Boundaries : North by Crown jungle ; east by Cham-manturai pattu ; south by Crown jungle ; west by Crown jungle.

II.

7.—*Wewgam Pattu North Division.*

Boundaries : North from the point where the Kuda-oya falls into the Magulawattavan-oya, a straight line drawn east south-east to the top of Balagala from thence a straight line to the top of the northern spur of Rakshagalla and thence a straight line to the highest point of the rocky ridge running north and south about a mile to the north north-west of Kachchikodiya Gangoda ; east, from this point a line running south south-east along the ridge and from the southern end of the ridge to the north-western end of Kachchikodiya tank bund, the said bund to its south-eastern extremity and thence a straight line running roughly south south-east to the junction of the cart road from Yothiankaddu with the Divulana-Vellaveli road, from this point a straight line running southwards to meet the northern branch of the Kalugal-aar, the said branch of Kalugal-aar westwards and south-westwards to the point where it meets the other branch, from this point, the southern branch of the Kalugal-aar running eastwards and south-eastwards as far as the eastern boundary of the Gonagolle tract of paddy fields, thence the eastern boundary of the said tract of paddy fields to its south-eastern corner, thence a straight line drawn southwards to the junction of the Uhana-ela with the Andella-oya, thence a straight line drawn south-eastwards to the top of the rocky hill situated about $\frac{1}{2}$ of a mile to the north-west of Veeragoda tank, thence a straight line drawn south-eastward to the point at which the Etinnawetichchakandura falls into the Veeragoda tank, thence the Etinnawetichchakandura south-westwards up to the point where it crosses the cart track from Heenveeradiya to Karangawa, from this point a straight line drawn to the highest point of the rocky hill lying about a mile to the west, from the top of this hill a straight line drawn south-westwards to the north-western point of Kondavaddavan tank, thence the contour of the said tank south-westwards, south-eastwards, westwards, and southwards to the point at which the Bakiniattawe-ela falls into the said tank, from this point a straight line drawn to the highest point of the rocky hill lying about 2 miles to the south, from this point a straight line drawn south south-eastwards to the Kanan-kadu irrigation bungalow from the said bungalow a straight line drawn south to meet the Gala-oya ; south, the Gala-oya ; west, the limits of Province of Uva up to the point where the boundary cuts the Magulawaddavan-oya, the Magulawaddavan-oya up to the point where the Kuda-oya falls into it.

8.—*Wewgam Pattu South Division.*

Boundaries : North, the Gala-oya ; east, from the Gala-oya a straight line drawn east to the large rock about 10 chains to the east of Muwuangalawewa bund, thence a straight line drawn south-eastwards to the summit of Ehenagala-ela, from the said summit a straight line drawn south-eastwards to the top of the rocky hill lying 3 miles to the north-east of Sagamam tank and about $\frac{1}{2}$ of a mile north of the Pannala-oya, thence a line drawn south to the Pannala-oya ; south, the Pannala-oya south-westwards to the point at which it crosses a line drawn due northwards from the northern spur of the hill line 2 miles to the west of Vammiyadi tank, thence the said line and the ridge of the said hill running southwards up to its highest point, from this point a straight line drawn south-westwards to Konduru-Hela Trigonometrical Station, from this Trigonometrical Station a line drawn west till it meets the Province boundary ; west, the limits of the Province of Uva.

9.—*Sammanturai Pattu West, Northern Division.*

Boundaries : North, the boundary of Wewgam pattu and a straight line drawn north-westwards from the junction of Veeraiadi-aru and Sengapadai-aru to meet the Wewgam pattu boundary slightly north of Malwatta ; east, the Gal-oya and Neindulla Vaikal ; south, the Gal-oya ; west, the boundary of Wewgam pattu.

10.—*Sammanturai Pattu West, Southern Division.*

Boundaries : North, the Gal-oya ; east, the boundary of Akkarai pattu ; south, the boundary of Akkarai pattu ; west, the boundary of Wewgam pattu.

I.

26.—*Chammanturai Pattu South Division.*

Boundaries: North by Chammanturai paddy fields and Chavalakkadai-Sadayantalawa road; south by Kalmadu and Virayadi rivers; east by Batticaloa lake and Karavaku paddy fields; and west by Crown jungle.

25.—*Chammanturai Pattu North Division.*

Boundaries: North by Porativu pattu; south by Chavalakkadai-Sadayantalawa road; east by Batticaloa lake; and west by Crown jungle.

16.—*Porativu Pattu North Division.*

Boundaries: North by Manmunai pattu; south by Batticaloa lake, Kalmaduvaddai, and Crown jungle; east by Batticaloa lake; and west by Crown jungle.

17.—*Porativu Pattu South Division.*

Boundaries: North by Batticaloa lake and Crown jungle; south by Chammanturai pattu; east by Batticaloa lake; and west by Crown jungle.

8.—*Manmunai South Division.*

Boundaries: North by Batticaloa lake and Crown jungle; south by Porativu pattu; east by Batticaloa lake; and west by Crown jungle.

9.—*Manmunai West, Southern Division, including Buffalo Island and Siraiyativu.*

Boundaries: North by Tettativu and Crown jungle; south by Makilur paddy fields and Crown jungle; east by sea; and west by Batticaloa lake.

17.—*Manmunai West, Northern Division, including the Islands of Mantivu and Vavvattivu.*

"THE MARRIAGE REGISTRATION ORDINANCE, 1927."

WHEREAS by Notification dated July 1, 1899, published in *Government Gazette* No. 5,629 of the same date, His Excellency the Governor, with the advice of the Executive Council, divided the Batticaloa District of the Island for the purposes of the registration of marriages into the 12 divisions specified in the schedule to the said Notification:

And whereas by Notification dated May 8, 1917, published in *Government Gazette* No. 6,875 of May 25, 1917, division No. 1 of the said district was subdivided.

And whereas it is expedient to amend and alter certain divisions and re-define the descriptions of the remaining divisions in the said district:

It is hereby notified that His Excellency the Governor in exercise of the powers vested in him by section 6 of "The Marriage Registration Ordinance, 1907," and with the advice of the Executive Council, has been pleased, with effect from January 1, 1929, to amend, alter, and re-define the descriptions of the marriage registration divisions of the said district more fully described in the first column of the annexed schedule in the manner specified in the second column thereof.

SCHEDULE.

Eastern Province—Batticaloa District.

I.

Mammunai Pattu North.

Boundaries: North, Eravur pattu; south, cart track, Batticaloa lake, and Kurukkalmadam; east, the sea; west, Rukam and Bintennai pattu.

Manmunai Pattu South.

Boundaries: North, a straight line from the junction of the Uhana-ela and the Andella-oya to the point at which the Mandur-Navalar cart track crosses the Punchigoda-aru, thence the said cart track north-westwards till it meets a straight line drawn due east and west through the point at which the Kurinchamunai road turns south-eastwards just to the south of Thampalayatta village, the said straight line westwards as far as the centre of the lake, thence a line drawn along the centre of the lake north-eastwards to meet the boundary of Eruvil pattu, the boundary of Eruvil pattu; south-eastwards as far as the boundary of Karawaku pattu; east, the boundary of Karawaku pattu and the boundary of Nintavur pattu, the Veeraiadi-aru westwards as far as the point at which it parts from Sengapadai-aru, from this point a line drawn slightly west of south to the point at which the old proposed forest reserve boundary crosses the Irrakkamam-Karunkodittivu cart track a little to the east of the 6th milepost; south, the said road westwards as far as the contour of Irakkamam tank, the southern contour of the said tank to its south-west corner, thence a straight line drawn west south-west to the top of Ehenagalahela; west, the boundary of Wewgam pattu from Ehenagalahela to the point at which the Uhana-ela falls into the Andella-oya.

No. 9.—*Wewgam Pattu.*

Boundaries: North, from the point where the Kuda-oya falls into the Magulawattawan-oya, a straight line drawn east south-east to the top of Balagala, from thence a straight line to the top of the northern spur of Rakshagala, and thence a straight line to the highest point of the rocky ridge running north and south about a mile to the north, north-west of Kachchikodiya gangoda, east from this point a line running south south-east along the ridge and from the southern end of the ridge to the north-western end of Kachchikodiya tank bund, the said bund to its south-eastern extremity, thence a straight line running roughly south south-east to the junction of the cart road from Yothiyankaddu with the Divulana-Wellaweli road from this point a straight line running southwards to meet the northern branch of the Kalugal-aar, the said branch of Kalugal-aar westwards and south-westwards to the point where it meets the other branch, from this point the southern branch of the Kalugal-aar running eastwards and south-eastwards as far as the eastern boundary of the Gonagolla tract of paddy fields, thence the eastern boundary of the said tract of paddy fields to its south-eastern corner, thence a straight line drawn southwards to the junction of the Uhana-ela with the Andella-oya, thence a straight line drawn south-eastwards to the top of the rocky hill situated about $\frac{1}{2}$ of a mile to the north-west of Veeragoda tank, thence a straight line drawn south-eastwards to the point at which the Ettinnewetichchakandura falls into Veeragoda

tank, thence the Etinnewetichchakandura, south-westwards up to the point where it crosses the cart track from Heenveeradiya to Karangawa, from this point a straight line drawn to the highest point of the rocky hill lying about a mile to the west, from the top of this hill a straight line drawn south-westwards to the north-western point of Kondavaddavan tank, thence the contour of the said tank south-westwards, south-eastwards, westwards, and southwards to the point at which the Bakiniattawa-ela falls into the said tank, from this point a straight line drawn to the highest point of the rocky hill lying about 2 miles to the south, from this point a straight line drawn south-eastwards to the Kanankadu Irrigation Bungalow, from the said bungalow a straight line drawn eastwards to the large rock about 10 chains to the east of the Muwangalawewa bund, thence a straight line drawn south eastwards to the summit of Ehenagala-ela from the said summit a straight line drawn south eastwards to the top of the rocky hill lying 3 miles to the north-east of Sagamam tank and about $\frac{1}{2}$ of a mile north of the Pannala-oya, thence a line drawn south to the Pannala-oya, south the Pannala-oya, south-westwards to the point at which it crosses a line drawn due northwards from the northern spur of the hill line 2 miles to the west of Vammiyadi tank, thence the said line and the ridge of the said hill running southwards up to its highest point, from this point a straight line drawn south-westwards to Konduruhela Trigonometrical Station, from this Trigonometrical Station a line drawn due west till it meets the Province boundary; west, the boundary between the Eastern Province and the Province of Uva up to the point where this boundary cuts the Magulawattawan-oya, the Magulawattawan-oya up to the point where the Kuda-oya falls into it.

No. 10.—*Akkarai Pattu.*

Boundaries: North, a straight line drawn from the top of Ehenagalahela to the south-west corner of Irakkamam tank, the southern contour of the tank as far as the Irakkamam-Karunkodittivu road, the said road eastwards to the point just west of the 6th milepost where the old proposed forest reserve boundary crosses the road, thence a straight line drawn northwards to the parting of the Veeraiadi-arua and the Sengapada-arua, and the said Veeraiadi-arua or Kaliodai as far as the sea; east, the sea; south, Panawa pattu and Wewgam pattu; west, Wewgam pattu as far as Ehenagalahela.

No. 11.—*Panawa Pattu.*

Boundaries: North, Akkarai pattu and Wewgam pattu; east, the sea; south, Kumbukkan-aar; west, the limits of Province of Uva.

No. 12.—*Bintenna Pattu.*

Boundaries: North, the boundary of Eravur pattu; east, the boundary of Manmunai North and Wewgam pattu as far as the Province of Uva boundary; south, Province of Uva boundary; west, Province of Uva boundary.

11.—*Panawa Pattu Division.*

Boundaries: North by Akkarai pattu; south by Kumbukkan-aar; east by the sea; west by the Province of Uva.

12.—*Bintenna Pattu Division.*

Boundaries: North by Rukam pattu; south by Province of Uva; east by Nadukadu and Porativu pattus and Crown jungle; west by Central Province and Province of Uva.
