### Land Acquisition Notices

#### THE LAND ACQUISITION ACT (CHAPTER 460)

##### Declaration under Section 5

I, John Anthony Emmanuel Amarathunga, Minister of Lands, hereby declare under Sub - Section (1) of Section 5 of the Land Acquisition Act, that the Lands described below are needed for a public purpose and will be acquired under the provisions of that Act.

Twelve (12) allotments of land depicted in Advance Tracing No. Ma/DMB/2016/177 dated 07.06.2016 prepared by the Surveyor General situated in the Village of E 440D, Welamitiyawa in the Divisional Secretary's Division of Dambulla in Matale District in Central Province and bounded as follows:

**01. Lot 'A' – Parayaya – Extent : 0.0559 Hectare**

North: Dewahuwa canal and Parayaya possessed by L.D. Piyarathna; East: Lot B; South: Parayaya possessed by L.D. Piyarathna; West: Dewahuwa canal.

**02. Lot 'B' – Parayaya – Extent : 0.0621 Hectare**

North: Road and land possessed by L.D. Piyarathna; East: Lot C; South: Lot C and Parayaya possessed by L.D. Piyarathna; West: Lot A.

**03. Lot 'C' – Extent : 0.0135 Hectare**

**05. Lot 'E' – Parayaya – Extent : 0.3702 Hectare**

North: Parayaya possessed by R.M. Lionel and Road; East: Lot F; South: Parayaya possessed by R.M. Lionel; West: Drain and Lot D.

**06. Lot 'F' – Extent: 0.0610 Hectare**

North: Lots C, J and M; East: Wemedillawewa; South: Lots F, N, K and L; West: Lot E and land possessed by R.M. Lionel.

**07. Lot 'G' – Parayaya – Extent: 0.0159 Hectare**

North: Parayaya possessed by N. Siriwardana and Lot J; East: Lots J and F; South: Lot F; West: Lot F and Road.

**08. Lot 'H' – Parayaya – Extent: 0.0009 Hectare**

North: Lots F and K; East: Parayaya possessed by N. Siriwardana; South: Parayaya possessed by R.M. Lionel; West: Lot F.

**09. Lot 'J' – Parayaya – Extent : 0.0471 Hectare**

North: Parayaya possessed by N. Siriwardana; East: Jungle of the Rangiri Dambulla Temple and Lot M; South: Lots F and G; West: Lot G.



**10. Lot 'K' – Parayaya – Extent : 0.0123 Hectare**

North: Lot F; East: Lots F and L; South: Jungle of the Rangiri Dambulla Temple, Parayaya possessed by N. Siriwardana and Lot H; West: Lots H and F.

**11. Lot 'L' – Parayaya – Extent : 0.0259 Hectare**

North: Lot F; East: Lot F and Wemedilla Wewa; South: Jungle of the Rangiri Dambulla Temple; West: Lot K and Parayaya possessed by N. Siriwardana.

**12. Lot 'M' – Parayaya – Extent : 0.0529 Hectare**

North: Parayaya possessed by N. Siriwardana and Jungle of the Rangiri Dambulla Temple; East: Wemedilla Wewa; South: Lot F; West: Lot J.
