#### THE LAND ACQUISITION ACT (CHAPTER 460)

##### Declaration under Section 5

I, John Anthony Emmanuel Amarathunga, Minister of Lands hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the lands described below are needed for a public purpose and will be acquired under the provisions of that Act.

Six (06) allotments of land, depicted in Advance Tracing No. KU/ALW/2016/396 dated 07th July 2016, prepared by the Surveyor-General, situated in the Village of Wennoruwa, No. 976 Wennoruwa-West and No. 984 Wigamuwa Watta in Grama Niladhari Divisions of, in the Divisional Secretary's Division of Alawwa, in Kurunegala District, in North Western Province and bounded as follows:
