"THE CEYLON POST OFFICE ORDINANCE, 1908."

RULES made by the Governor in Executive Council under sections 9 and 10 of "The Ceylon Post Office Ordinance, 1908."

Rules.

- 1. Rule 38 of the rules under "The Ceylon Post Office Ordinance, 1908," published in Supplement to the Government Gazette No. 6,297 of February 26, 1909, as finally amended by Notification dated July 27, 1928, published in Gazette No. 7,656 of the same date, is repealed and the following is substituted therefor:—
 - 38. Postage.—The rates of postage on letters shall be as follows:-

For letters: 6 cents for every 2 ounces.

For district letter not exceeding 2 ounces in weight: 3 cents each letter.

- 2. Rule 41 of the rules under "The Ceylon Post Office Ordinance, 1908," published in Supplement to the Government Gazette No. 6,297 of February 26, 1909, as finally amended by Notification dated January 25, 1928, published in Gazette No. 7,626 of January 27, 1928, is repealed and the following is substituted therefor:—
 - 41. Post Cards.—The postage on post cards shall be 3 cents on each card. A private post card posted unpaid shall be charged on delivery with double postage, and if posted insufficiently prepaid, it shall be charged on delivery with double the amount of the deficiency.
 - 3. These rules shall come into operation on October 1, 1929.

"THE LABOUR ORDINANCE, No. 1 of 1923."

Notification No. 34.

IT is hereby notified that His Excellency the Governor, in Executive Council, in pursuance of regulation 1A, Chapter I., of the regulations made by the Governor in Executive Council, under the powers conferred by section 14 of "The Labour Ordinance, No. 1 of 1923," as amended by Notification No. 8 of the Department of Indian Immigrant Labour dated October 24, 1923, and published in the Government Gazette No. 7,358 of October 26, 1923, has been pleased to declare that the quarterly instalment in respect of acreage fees, payable on or before October 1, 1929, to the Controller by employers of any Indian labourers on any estate of the description named in Schedule A attached to the said regulations, shall be on the following scales:—

75 cents per acre for tea; and 25 cents per acre for rubber, cacao, or cardamoms.
