I, Canagasabapathy Viswalingam Wigneswaran Chief Minister and Minister of Finance Northern Provincial Council, declare that Stamp Duty shall be chargeable with effect from 08th July 2015 on every instrument specified in Column I of the Schedule hereto at the rates specified in the corresponding entry in Column II of that Schedule.
