The return required by section 8 (2) of the Ordinance to be forwarded by a certificate holder shall be forwarded by him within 10 days after every race-meeting held on the registered racecourse for which he holds a certificate of registration, and shall be in the Form C in the Appendix to these regulations. The amount of the totalisator tax due in respect of every such race-meeting shall be made over by the certificate-holder together with the said return, in such manner as the prescribed officer shall require.
