**FINAL ORDERS.****Kalutara S. O. No. 139.****Order under Section 4, Sub-section (1), of "The Waste Lands Ordinances of 1897, 1899, 1900, 1903, and 1927."**

In the matter of the land commonly called or known as Kosgahawattepitakattiya, situate in the village of Diyapattugama, in the Maha pattu south of the Pasdun korale east of the Kalutara District, in the Western Province, and of "The Waste Lands Ordinances of 1897, 1899, 1900, and 1903."

WHEREAS in pursuance of section 1 of the said Ordinances it was duly declared and notified on the 26th day of November, 1926, that if no claim to the land commonly called or known as Kosgahawattepitakattiya, situate in the village of Diyapattugama, in the Maha pattu south of the Pasdun korale east of the Kalutara District, in the Western Province, containing in extent 1 rood and 18 perches, and shown as lot 79 in block survey preliminary plan No. 101, was made to Walter Terence Stace, Esq., Special Officer appointed under section 28 of the said Ordinances, within the period of three months from the date specified in the said notice, such land would be declared the property of the Crown, and dealt with on account of the Crown (*vide* Notice No. 9,389):
