PROCLAMATION.

By His Excellency Sir ARTHUR ELIBANK HAVELOCK, Knight Commander of the Most Distinguished Order of Saint Michael and Saint George, Governor and Commander-in-Chief in and over the Island of Ceylon, with the Dependencies thereof.

A. E. HAVELOCK.

HEREAS by the 34th section of "The Forest Ordinance, 1885," it is enacted that the Governor may, by Proclamation in the Gazette, constitute any portion of forest a village forest, for the benefit of any village community or group of village communities, and may in like manner vary or cancel any such Proclamation:

And whereas it is further enacted that every such Proclamation shall specify the limits of such village forest:

And whereas it is expedient to constitute a village forest for the benefit of the group of village communities consisting of the villages Panagoda, Godagama, Habarakada, Homagama, Aturugiriya, Ind Pore, in the Héwágam kóralé of the Western Province:

Now know Ye that We, the said Governor, do by this Our Proclamation constitute the forest specified in the schedule hereto a village forest for the benefit of the group of village communities consisting of the villages Panagoda, Godagama, Habarakada, Homagama, Aturugiriya, and Pore, in the Héwagam koralé of the Western Province.

Given at Nuwara Eliya, in the said Island of Ceylon, this Twenty-third day of April, in the year of our Lord One thousand Eight hundred and Ninety-five.

Bounded on the north by Millegahawatta, property of Naullage people; Millagahakumbura, property of Mututantirige Samuel and others.

East by the village boundary of Megoda.

South by the village boundary of Gehenuwala, by the property of John David Perera, Mudaliyár, and Mudun-kissiyakumbure belonging to Wellappulige Mudalihami.

West by the property of Julius Pieris, Mudaliyár, by the ditch of the garden of Weralupitiyage Girigoris Appu, by Talgahawatta, property of Kuruvitage Don Cornelis, by land purchased from the Crown by Mututantirige Saran Appu and others, by Wellussani Kisseyakumbura, property of Lekange Handahami, by the fields of Mututantirige Samel and Vitanage Don Telenis and others, and Sendanayeka-achchige Pinhamy, Mututantirige Samel, and Nanayakkaragamage Don Cornelis and others.

1. Rights of felling timber, of collecting forest produce, or of pasturing cattle in a village forest may be exercised only by the permanent residents of the village or villages named in the Proclamation constituting such forest a village forest.

2. The under-mentioned trees may not be cut without the permission of a forest officer empowered to grant such permission, as provided in the Ordinance: kaluwara, kalumediriya, na, milla, nedun, kos, del, mendora, kina, lunumidella, tala, tekka, or walsapu.

3. No trees of any kind over one cubit in girth at four feet from the ground may be cut without a permit from the Kóralé Mudaliyár.

4. Dead or fallen timber for firewood, sticks for fences and tool handles, and canes and creepers may be cut without any permit.

5. No person may sell, barter, or give away any timber or forest produce taken from a village forest to persons outside of the village community.

6. No person may cut any timber, or collect any forest produce, or pasture cattle in excess of his actual personal requirements at any one time, except to sell, barter, or give away to other members of the village community.
