REGULATIONS

- All applications for graves shall be made to the Cemetery keeper not less than 6 hours before the time fixed for the burial of a person for whom the grave is wanted.
- No one shall be allowed to dig a grave except the person employed or approved by the keeper.
- The keeper shall intimate the line to be followed by the funeral party on arriving at the cemetery, and if more than one party come at the same time, the order in which they are respectively to move to the graves.
- Should it be necessary for the purposes of preventing the disturbance of one funeral party by another, and not otherwise, the keeper may require that one burial service should be concluded before another is commenced.
- The keeper shall be entitled to maintain order within the cemetery and his commands in that behalf shall be obeyed.
- No grave shall be less than 5 feet in depth or at a less distance than 1½ feet from another.
- No dead body shall be buried without the permission of the Cemetery keeper; such permission shall not be granted until all fees due have been paid and a certificate of registration of death produced.
- The following fees shall be paid by applicants for graves at the time of application in respect of the general cemetery only.

For digging a full-sized grave	2 50
For digging a grave for a child under 10 years	1 50
For every cremation	10 0
For a monument or grave stone not exceeding 8 feet square	30 0

Provided that, on production of a certificate signed by a person especially authorized in that behalf in writing by the Chairman, Sanitary Board, that the relatives and friends of any deceased person are not able to pay the fees therein authorized for the digging of a grave, the keeper of the cemetery shall cause a grave to be dug and the corpse to be buried therein free of charge.

VITAL STATISTICS.

Registrar-General's Report on Vital Statistics of the City of Colombo for the Week ended May 9, 1931.

Births.—The total births registered in the city of Colombo in the week were 162 (2 Europeans, 16 Burghers, 96 Sinhalese, 20 Tamils, 16 Moors, 10 Malays, and 2 Others). The birth rate per 1,000 per annum (calculated on the estimated population on January 1, 1931, viz., 282,870) was 29.9, as against 24.7 in the preceding week, 26.0 in the corresponding week of last year, and 33.9 the weekly average for last year.

Deaths.—The total deaths registered were 112 (4 Europeans, 4 Burghers, 58 Sinhalese, 21 Tamils, 13 Moors, 1 Malay, and 11 Others). The death rate per 1,000 per annum was 20.6, as against 21.9 in the previous week, 24.8 in the corresponding week of last year, and 29.5 the weekly average for last year.

Infantile Deaths.—Of the 112 total deaths, 18 were of infants under one year of age, as against 20 in the preceding week, 30 in the corresponding week of the previous year, and 32 the average for last year.

Stillbirths.—The number of stillbirths registered during the week was 6.

Principal Causes of Death.—1. (a) Sixteen deaths from *Pneumonia* were registered, 12 in Maradana hospitals (including 6 deaths of non-residents), 2 in Kotahena North, and 1 each in St. Paul's and Kotahena South, as against 23 in the previous week and 18 the weekly average for last year.

(b) Ten deaths from *Influenza* were registered, 4 in New Bazaar and 2 each in St. Paul's, San Sebastian, and Maradana hospitals (including 1 death of a non-resident), as against 6 in the previous week and 8 the weekly average for last year.

(c) Four deaths from *Bronchitis* were registered, 2 in Wellawatta North and 1 each in Maradana North and Wellawatta South. The number registered during the preceding week as also the weekly average for last year was 4.

2. (a) Seven deaths from *Phthisis* were registered, 5 in Maradana hospitals (of non-residents) and 1 each in Maradana North and Kollupitiya, as against 6 in the previous week and 12 the weekly average for last year.

(b) One death from *Phthisis*, of a resident of Colombo town, occurred at the Anti-Tuberculosis Hospital, Ragama, during the week.

3. Seven deaths from *Enteric Fever* were registered, 5 in Maradana hospitals (including 2 deaths of non-residents) and 1 each in Kotahena South and Slave Island, as against 3 in the previous week and 4 the weekly average for last year.

4. One death from *Plague* was registered in St. Paul's, as against nil in the previous week and 1 the weekly average for last year.

5. Five deaths from *Enteritis* were registered, 4 each from *Worms* and *Debility*, 3 from *Accidents*, 2 from *Dysentery*, 1 each from *Diarrhoea*, *Infantile Convulsions*, *Homicide*, *Suicide* and *Puerperal Septicæmia*, and 44 from *Other Causes*.

6. **Reported Cases.**—Sixteen cases of *Chickenpox*, 13 of *Enteric Fever*, 1 of *Measles*, and 1 of *Plague* were reported during the week, as against 17, 10, nil, and nil, respectively, of the preceding week.

State of the Weather.—The mean temperature of air was 82.0°, against 81.7° in the preceding week, and 79.1° in the corresponding week of the previous year. The mean atmospheric pressure was 29.791 in., against 29.835 in. in the preceding week, and 29.775 in. in the corresponding week of the previous year. The total rainfall in the week was 5.44 in. against 1.34 in. in the preceding week, and 19.83 in. in the corresponding week of the previous year.
