DRAFT ORDINANCES.**MINUTE.**

The following Draft of a proposed Ordinance is published for general information :—

An Ordinance to amend The Local Loans and Development Ordinance No. 22 of 1916 as amended by the Local Loans and Development Amendment Ordinance 1930.

BE it enacted by the Governor of Ceylon, by and with the advice and consent of the State Council thereof, as follows :—

1 This Ordinance may be cited as the Local Loans and Development Amendment Ordinance 1931.

2 Section 14 of the principal Ordinance is hereby amended by the repeal of sub-section (3) thereof, and the substitution of the following sub-section therefor :—

“(3) The Commissioners may, if they think fit, in the case of any society registered under the Co-operative Societies Ordinance No. 34 of 1921 dispense with any security other than an obligation binding upon the Society and its members.”

Objects and Reasons.

The right of the Local Loans and Development Commissioners to advance money without the security of a mortgage is limited by section 14 (3) of the Local Loans and Development Ordinance No. 22 of 1916 to loans to co-operative societies, because in 1916 it was assumed that all co-operative societies would be co-operative credit societies. But the Ordinance that induced this assumption, viz., The Co-operative Credit Societies Ordinance, 1911, was replaced by The Co-operative Societies Ordinance No. 34 of 1921 and in consequence a limitation similarly founded in section 8 was removed by the Local Loans and Development Amendment Ordinance 1930. A parallel alteration in section 14 (3) which should then have been made is now effected by this Bill.

MINUTE.

The following Draft of a proposed Ordinance is published for general information :—

An Ordinance to amend the School Teachers' Pension Ordinance, No. 6 of 1927.

BE it enacted by the Governor of Ceylon, with the advice and consent of the State Council thereof, as follows :—

1 This Ordinance may be cited as The School Teachers' Pension (Amendment) Ordinance, 1931.

2 Section 1 of the principal Ordinance is hereby amended by substituting the words “first day of August 1927” for the words “on a day to be fixed by the Governor by Proclamation in the Government Gazette”.

3 The principal Ordinance shall be generally construed as if from the time of its passing section 1 thereof had read as amended by the last preceding section, and particularly therefore—

(a) the said Ordinance shall be deemed to have come into operation on the first day of August 1927;

(b) all rules which purport to have been duly made under the said Ordinance before the passing of this Ordinance shall be deemed to have been validly made as from the date of their making;

- (c) all pensions gratuities and allowances granted in accordance with the said rules shall be deemed to have been validly and properly paid on and from the time at which they were paid; and
- (d) all other acts and things that purport to have been done by virtue of the provisions of the said Ordinance or rules shall on and from the time at which they were so done be deemed to have been validly and properly done, and such acts and things shall in all respects be as valid and effectual as if the said Ordinance had come into operation on the first day of August 1927.

Objects and Reasons.

The School Teachers' Pension Ordinance, No. 6 of 1927, had to be brought into force by a Proclamation under section 1 fixing the date on which it was to come into operation. Though such a proclamation does not appear to have been issued the Ordinance has been acted upon as if it had come into operation on the 1st of August 1927 when it received the assent of the Governor. This Ordinance therefore seeks to validate all matters done on the basis that the principal Ordinance became law on that date. Clause 1 accordingly amends section 1 by fixing the 1st of August 1927 as the time at which the principal Ordinance came into force, and clause 2 specifically ratifies all acts which purport to have been done in pursuance of the powers under the principal Ordinance.
