Order made by the Governor under Article 94 of the Ceylon (State Council) Order in Council, 1931.

IN exercise of the powers vested in the Governor by Article 94 of the Ceylon (State Council) Order in Council, 1931, it is hereby ordered that, subject to such conditions and limitations as the Governor may from time to time prescribe, the powers, authorities, and functions vested in the Governor, or in the Governor in Executive Council, by the written law specified in the first column in the schedule to this Order, shall, from and after the Ninth day of July, 1931, be vested in the officer or authority indicated in the second column of the said schedule.
