## FINAL ORDERS.

### Order under Section 2 of "The Waste Lands Ordinances of 1897, 1899, 1900, 1903, and 1927," declaring Land to be the Crown Property in Absence of Claim.

In the matter of the land commonly called or known as Uppukali, situate in the village of Andankani in Akkarai pattu north of Kalpitiya division, in the Puttalam District of the North-Western Province, and of "The Waste Lands Ordinances of 1897, 1899, 1900, 1903, and 1927."

WHEREAS in pursuance of section 1 of the said Ordinances it was duly declared and notified on the 10th day of April, 1931, that if no claim to the land commonly called or known as Uppukali, situate in the village of Andankani in Akkarai pattu north of the Kalpitiya division of the Puttalam District, in the North-Western Province, containing in extent 3 acres 1 rood and 20 perches, and shown as lot 66 in preliminary plan No. 4,852, was made to the Assistant Government Agent of the Puttalam and Chilaw Districts, in the North-Western Province, within the period of three months from the date specified in the said notice, such land would be declared the property of the Crown (*vide* Notice No. 10,850):
